The Emergency Council also reviews and recommends the adoption of such ordinances, resolutions, rules and regulations as may be necessary to implement the County Emergency Plan or other mutual aid agreement entered into pursuant to such plan. <p>North Coast Air Basin Control District (1P + 1 Alt)</p>	<p>Air districts are grouped by air basins which represent an air shed. Northern Sonoma County belongs to the North Coast Air Basin along with Mendocino County Air Quality Management District (AQMD) and the North Coast Unified AQMD. By statute, these Districts are members of the North Coast Air Basin Control Council (BCC). A representative from Lake County Air Pollution Control District also participates through an MOU. Community Advisory Board of the public water transportation system that Francisco Bay Water Transit Authority (No official term)	Assists and advises the WETA Board of Directors in carrying out its functions as a regional agency with responsibility for establishing and operating a comprehensive Community Advisory Board of the San public water transportation system that Francisco Bay Water Transit Authority connects communities, reduces congestion, and provides an emergency response capability. Members are primarily elected officials from around the bay area. WETA was established by SB 976, and replaces the WTA (Water Transit Authority).
