**Executive Summary:**

Staff is presenting for consideration and approval the 2026 Key Items Calendar. This calendar was previously referred to as the "The Calendar Items of Significant Interest."

On November 17, 2020, the Board of Supervisors approved board staff report template to include new policies which include the application of the Equity Toolkit. Several of the anticipated Key Items programmed for 2026 include recommendations for which an equity analysis will be expected to strengthen the information available for the Board's consideration.
