**Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,  
Authorizing Adjustments For Various Fees Supporting Residence Maintenance Fees, Camp Fees,  
Enhanced Recreational Programs and Annual Parking Fees Volume Rate Structure; And New Fees  
For Hourly Rates For Grass Field Rentals, Tennis And Pickleball Court Rentals and Classroom Based  
Field Trips.**

**Whereas,** The County of Sonoma owns and operates sixty Regional Parks, trails and other facilities; and

**Whereas,** it is in the best interest of the County of Sonoma and the general public to maintain and operate said facilities and at a standard of care that provides for the welfare, safety and enjoyment of park visitors;

**Whereas,** adjustments to various fees supporting residence maintenance fees, school field trips and educational programs, camp fees, enhanced recreational programs, annual parking feeds (memberships) will increase revenue so General Funds do not have to be used to pay for these services provided to the fee payors;

**Now, Therefore, Be It Resolved** that to recover the reasonable cost of providing certain parks services, it is necessary to increase certain fees and establish certain new fees as set forth below:
