1. PROBLEM STATEMENT

Sonoma County is a great place to live, work, and visit! The local economy boasts a prestigious wine industry, an impressive collection of craft breweries, an increasing number of distilleries, as well as award-winning cannabis cultivation and dispensaries. The City of Santa Rosa is the county seat and the largest city in the county. The city's tourism website, VisitSantaRosa.com, grabs attention with slogans like "Where Wine Country Meets Beer City," and "Mother Nature Does Her Best Work Here." It is a beautiful place for wine, spirits, microbrews, and cannabis. Locals and visitors alike enjoy the concerts, gambling, food, and bars at the county's two casinos, one of which is currently undergoing a \$1 billion expansion that will double its capacity. Events throughout the county attract visitors all year long from farmers markets and musical entertainment to seasonal events celebrating the uniqueness of Sonoma County communities and the products they produce. Many events are centered around the alcoholic beverages the hosts are promoting, however even those not centered around alcohol are bolstered by sales to participants, increasing the potential for impaired driving on county roads.

Most events have returned to in person after years of COVID restrictions, although many have embraced small "boutique" style experiences in place of large-scale events. A caveat to these smaller and more scaled down experiences is some of the safer modes of transportation, vans, buses, e-taxis, are not as available or cost efficient to these smaller groups, putting more people behind the wheel to drink/drug and drive to multiple locations. 30% of our office open cases are for defendants from outside of our county.

Five-year statistics for Sonoma County from 2017-2021 show a concerning percentage increase in alcohol involved crashes that resulted in victim fatalities and/or injury, jumping from 13% to 19%. Also on the rise, since pre-COVID year 2019 lows, are underage and young adult alcohol involved crashes resulting in fatalities and/or injury. A 2019 survey by (PSB) Research found that while two-thirds of Americans think it is unsafe to drive under the influence of cannabis, over half of cannabis users think it is safe to drive high and are more willing to be a passenger in a car with a driver who is high. Research studies have found that there is a direct link between the psychoactive chemical in marijuana, tetrahydrocannabinol (THC),) concentration in the blood and impaired driving skills, and the risk of being involved in a crash increases after a driver uses marijuana. Prosecuting cases involving marijuana is challenging in the absence of a reliable test to determine the level of THC present in a driver at the time of a crash, however more law enforcement officers are becoming Drug Recognition Experts to expand their traditional investigation techniques to address the unique circumstances related to marijuana impairment.

Since the Tubbs fire ravaged the County in 2017, subsequent years have come with their own emergency events. In 2018, the community was affected by dangerous air quality due to smoke from the Camp Fire in Paradise triggering trauma from the local fire experience just one year before. In addition to flooding, 2019 brought more fires, and lightning strikes in 2020 resulted in even more fires that devastated both rural and residential areas of the county. Storms in 2023 brought more flooding of the Russian River. The consistent, cumulative traumas experienced by Sonoma County residents has been overwhelming, and research shows a strong link between increased incidents of trauma leading to increased use of drugs and alcohol, making county roads less safe.

The current Sonoma County District Attorney Vertical Driving Under the Influence (DUI) team prosecutes the most serious and complicated DUI cases and is staffed by two full-time attorneys and two DA investigators. Together they secured 577 convictions during the 2022/2023 grant year. The expertise of this team is instrumental in successfully holding DUI offenders accountable, but the workload is difficult to manage. The prosecutors are often spread between multiple courtrooms where they are constantly pushed and pulled in different directions to handle multiple daily appearances. Meeting with victims is difficult with the daily demands of reviewing new cases and multiple court appearances. It is ideal to attack these cases with the expertise of the vertical unit, making it impractical to utilize other staff for support.

3. METHOD OF PROCEDURE

A. Phase 1 - Program Preparation (1st Quarter of Grant Year)

- Recruit and hire all staff for the grant.
- Procure all materials necessary to implement the grant.
- Identify dates and schedule the four in person Roundtable Meetings (one each quarter with telephone or video conference capabilities). Notify the OTS coordinator of the dates. Meetings are meant to provide information on the DUI Vertical Prosecution Program, interact with law enforcement to identify means to improve DUI investigation and prosecution, and assess technical assistance needs for training on DUI investigation and court testimony. OTS staff, TSRP staff, local law enforcement, CHP, and probation staff should be included in the roundtable. Agenda and minutes should be produced and distributed. All four meetings for the year should be scheduled in the first quarter of the grant.
- Develop protocols to be used to measure the success of the DUI Prosecution Program.
- Conduct training for all program staff outlining the goals and objectives of the grant.
- Refer cases for prosecution to the grant-funded Deputy District/City Attorney(s).
- Transfer all pending DUI cases which qualify under this program so that vertical prosecution may begin.
- Develop a training protocol for law enforcement agencies within the county, and start a process of coordinating all reporting, investigation, and referral of cases that qualify under the grant.

Media Requirements:

 Issue a press release approved by the OTS PIO announcing the kick-off of the grant by November 15, but no sooner than October 1. The kick-off release must be approved by the OTS PIO and only distributed after the grant is fully signed and executed. If you are unable to meet the November 15 deadline to issue a kick-off press release, communicate reasons to your OTS grant coordinator and OTS PIO.

B. Phase 2 – Program Operations (Throughout Grant Year)

- Prosecution will be on-going. The Deputy District/City Attorney(s) will review DUI cases from all law enforcement agencies in the county/city.
- Training for law enforcement personnel, District Attorney Investigators, and other Deputy District/City Attorneys will begin and continue throughout the program.
- Prosecutor(s) will:
- a) Work to secure convictions (as justice requires) and appropriate sentences that reflect the public safety risk posed by the offender.
- b) Mentor trial attorneys on how to successfully try high-risk DUI offenders.
- c) Host Quarterly Roundtable meetings with law enforcement personnel, TSRP, and OTS Coordinator.
- d) Work with the TSRP to obtain and deliver high quality DUI prosecution training programs to non-grant-funded prosecutors.
- e) Work with the TSRP to obtain and deliver high quality DUI investigation, report writing, and courtroom testimony training programs to law enforcement personnel (police officers, deputies, District Attorney Investigators, and crime lab scientists).
- f) Attend training programs that cover evaluation and preparation of DUI drug cases, marijuana, prescription drugs, drug trends, people's experts, defense challenges, cross-examination of experts, SFST evidence, jury considerations and toxicology evidence, and incorporate this information into DUI trainings for attorneys and law enforcement personnel.
- g) Send the funded vertical prosecutor(s) and investigator to the NHTSA "Advanced Roadside Impaired Driving Enforcement" (ARIDE) 16 hour POST-Certified training, if not already trained. Note: The funded vertical prosecutor(s) and investigator(s) should achieve this objective within the first quarter of the grant.

Media Requirements

The following requirements are for all grant-related activities:

Optimum lead time would be 7 days before the scheduled release but at least 3 business days prior to the scheduled release date for review and approval is appreciated.
- Send all Powerpoint presentations, online presentations and trainings for grant-related activities
 to the OTS PIO at <u>pio@ots.ca.gov</u> for approval and copy your OTS grant coordinator. Certified
 training courses are EXEMPT from the approval process.
- The OTS PIO is responsible for the approval of the design and content of materials. The agency understands OTS PIO approval is not authorizing approval of budget expenditure or cost. Any cost approvals must come from the OTS grant coordinator.
- Pre-approval is not required when using any OTS-supplied template for media advisories, press
 releases, social media graphics, videos or posts, or any other OTS-supplied educational material.

- 1. The recipient shall maintain a written code or standards of conduct that provide for disciplinary actions to be applied for violations of such standards by officers, employees, or agents.
 - a. The code or standards shall provide that the recipient's officers, employees, or agents may neither solicit nor accept gratuities, favors, or anything of monetary value from present or potential subawardees, including contractors or parties to subcontracts.
 - b. The code or standards shall establish penalties, sanctions, or other disciplinary actions for violations, as permitted by State or local law or regulations.
- 2. The recipient shall maintain responsibility to enforce the requirements of the written code or standards of conduct.

DISCLOSURE REQUIREMENTS

No State or its subrecipient, including its officers, employees, or agents, shall perform or continue to perform under a grant or cooperative agreement, whose objectivity may be impaired because of any related past, present, or currently planned interest, financial or otherwise, in organizations regulated by NHTSA or in organizations whose interests may be substantially affected by NHTSA activities. Based on this policy:

- 1. The recipient shall disclose any conflict of interest identified as soon as reasonably possible, making an immediate and full disclosure in writing to NHTSA. The disclosure shall include a description of the action which the recipient has taken or proposes to take to avoid or mitigate such conflict.
- 2. NHTSA will review the disclosure and may require additional relevant information from the recipient. If a conflict of interest is found to exist, NHTSA may (a) terminate the award, or (b) determine that it is otherwise in the best interest of NHTSA to continue the award and include appropriate provisions to mitigate or avoid such conflict.
- 3. Conflicts of interest that require disclosure include all past, present, or currently planned organizational, financial, contractual, or other interest(s) with an organization regulated by NHTSA or with an organization whose interests may be substantially affected by NHTSA activities, and which are related to this award. The interest(s) that require disclosure include those of any recipient, affiliate, proposed consultant, proposed subcontractor, and key personnel of any of the above. Past interest shall be limited to within one year of the date of award. Key personnel shall include any person owning more than a 20 percent interest in a recipient, and the officers, employees or agents of a recipient who are responsible for making a decision or taking an action under an award where the decision or action can have an economic or other impact on the interests of a regulated or affected organization.

PROHIBITION ON USING GRANT FUNDS TO CHECK FOR HELMET USAGE (applies to all subrecipients as well as States)

The State and each subrecipient will not use 23 U.S.C. Chapter 4 grant funds for programs to check helmet usage or to create checkpoints that specifically target motorcyclists.

POLICY ON SEAT BELT USE

In accordance with Executive Order 13043, Increasing Seat Belt Use in the United States, dated April 16, 1997, the Grantee is encouraged to adopt and enforce on-the-job seat belt use policies and programs for its employees when operating company-owned, rented, or personally-owned vehicles. POLICY ON BANNING TEXT MESSAGING WHILE DRIVING

In accordance with Executive Order 13513, Federal Leadership On Reducing Text Messaging While Driving, and DOT Order 3902.10, Text Messaging While Driving, States are encouraged to adopt and enforce workplace safety policies to decrease crashes caused by distracted driving, including policies to ban text messaging while driving companyowned or rented vehicles, Government-owned, leased or rented vehicles, or privately-owned vehicles when on official Government business or when performing any work on or behalf of the Government. States are also encouraged to conduct workplace safety initiatives in a manner commensurate with the size of the business, such as establishment of new rules and programs or re-evaluation of existing programs to prohibit text messaging while driving, and education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
