The Sheriff's Office does...	The Sheriff's Office does <u>not</u> ...
<ul style="list-style-type: none">• Protect public safety• Help undocumented victims get U-Visas• Provide inmate release dates to ICE pursuant to State law, and to the public as requested.• Inmates can request a review.• Send inmate fingerprints to the State Department of Justice	<ul style="list-style-type: none">• Enforce Federal immigration law• Have authority over ICE• Deport anyone• Conduct immigration sweeps• Contact someone based only on his/her immigration status• Contact ICE to determine an immigration status• Accept immigration violation complaints

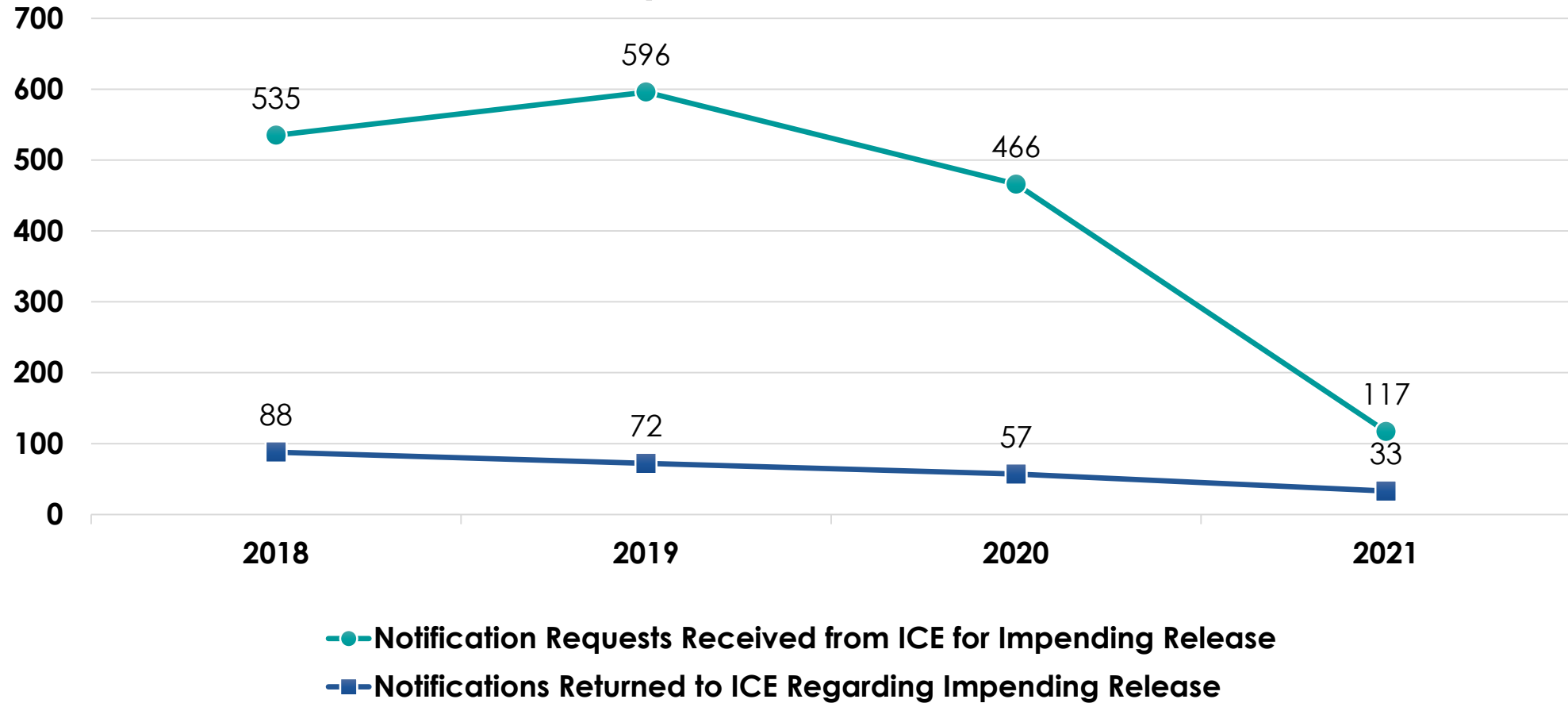

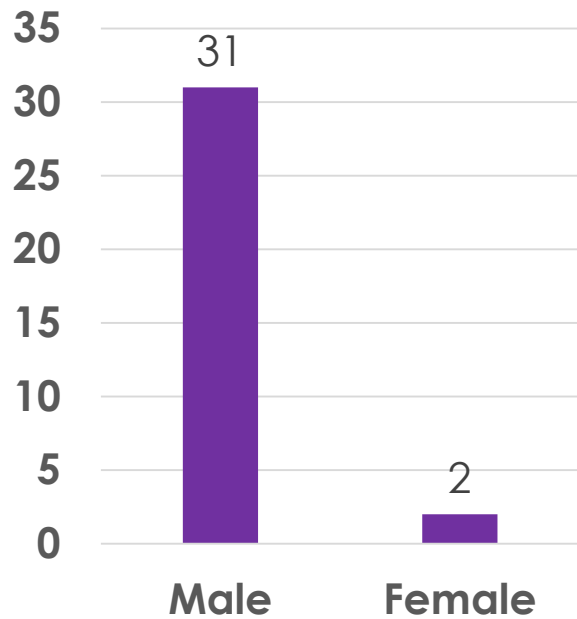
Multi-Year Trend

Sonoma County ICE Access Data 2018 - 2021

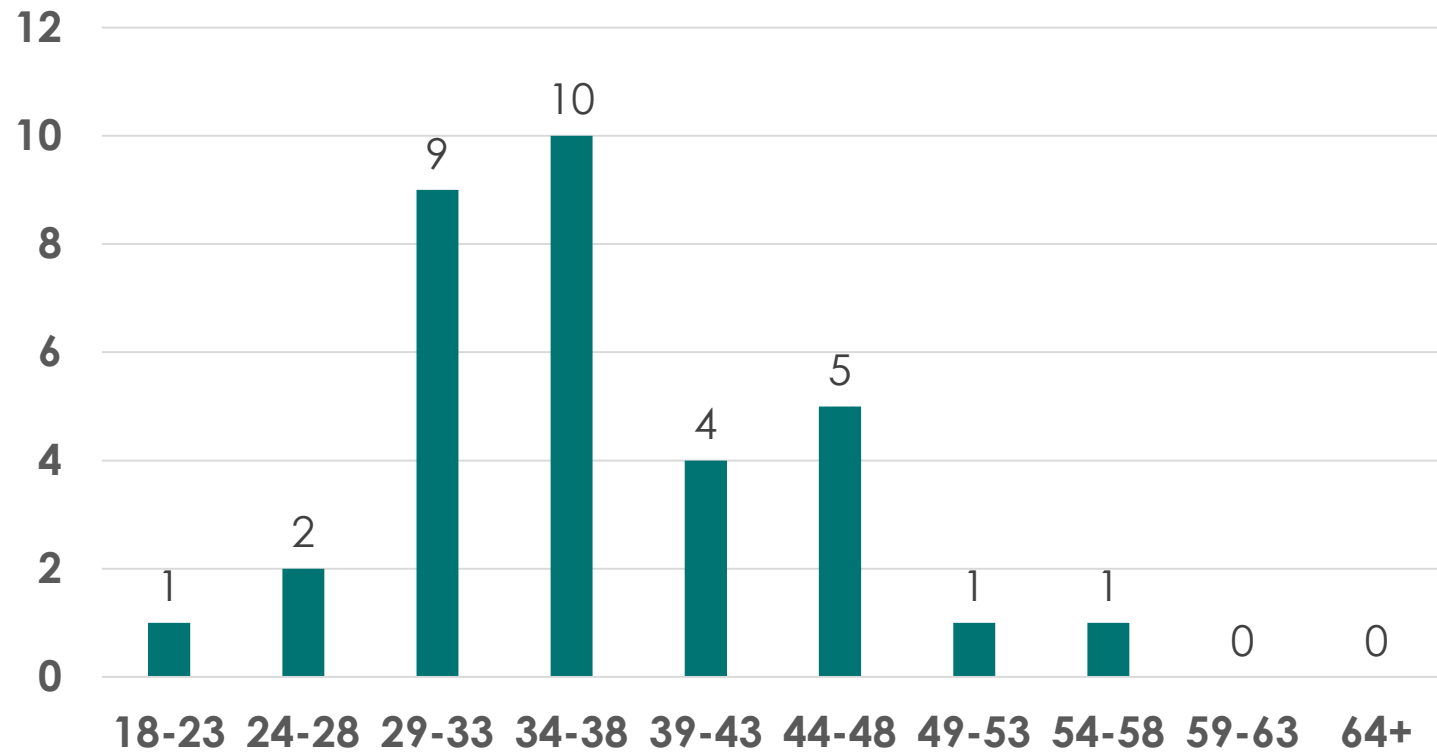
