I found that we have taken three crime reports since 1/1/2020 within 3,000 feet of the property in question. The one that was reported at the property in question is a credit card fraud that occurred out of state with the victims information. The other two seem unrelated to the property as one was a theft of solar panels and the other was another credit card fraud that occurred out of the area.
