**Resolution Of The Board Of Directors Of The Sonoma County Water Agency
Declaring Intention To Reimburse Expenditures From The Proceeds Of Tax-
Exempt Obligations**

WHEREAS, the Sonoma County Water Agency ("Sonoma Water") intends to acquire and construct certain capital projects consisting of and including, without limitation, those projects listed on Attachment A hereto (collectively, the "Projects"); and

WHEREAS, in order to obtain funds for the Projects, Sonoma Water intends to authorize the issuance and sale of its revenue bonds (the "Bonds"); and

WHEREAS, in order to use the proceeds of the Bonds to reimburse advances made by Sonoma Water before the date of issuance of the Bonds, but not more than 60 days before the date of adoption of this Resolution, Section 1.150-2 of the United States Income Tax Regulations requires that Board of Directors of Sonoma Water declare its intention to reimburse such advances from the proceeds of the Bonds; and

WHEREAS, it is in the public interest and for the public benefit that Sonoma Water declare its official intent to reimburse the expenditures referenced herein to implement the financing plan for the Projects.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Sonoma Water, as follows:

- 1. Declaration of Intent.** The Board of Directors hereby declares that it reasonably expects to issue the Bonds and to use a portion of the proceeds thereof to reimburse expenditures made by Sonoma Water for the Projects before the date of issuance of the Bonds, and not more than 60 days before the effective date of this Resolution. Sonoma Water anticipates that the Bonds will be issued in a maximum original principal amount of approximately \$35,000,000.

2. **Purposes.** The adoption of this resolution shall be solely for the purposes of complying with the United States Income Tax Regulations and evidencing the intention of this Board of Directors to reimburse itself from the proceeds of the Bonds, if and when issued, and shall not be deemed a final approval of all or any part of the Projects or a final commitment on the part of Sonoma Water to issue any or all of the Bonds.
3. **Effective Date.** This resolution shall take effect immediately upon its adoption.
