Summary of Individuals Served

The American Rescue Plan Act Community Resilience Program (ARPA CRP) continues to be a positive demonstration for how the County can better collect demographic data through healing-centered approaches to assess the impact of County investments. This expanded use deepens the approach to collecting demographic data using the Upstream Investments Shared Outcomes System (SOMS) and tells a broader story about the impact of the ARPA CRP. Data collection in SOMS began January 1, 2023. Prior to January, the SOMS system was not completed for the ARPA-CRP expansion and only the federal ARPA requirements were being collected. The tables below share key highlights from January 1, 2023 - June 30, 2024.

Multiple types of data are being collected to communicate the impact of the ARPA CRP. The intake for programs offering ongoing services includes personal identifiable information (PII), which allows us to follow a person across programs to assess broader impact. Programs offering one-time services or group activities are collecting non-PII. Both datasets include demographic data collection, but because non-PII doesn't attach the service provided to an individual, it can't be compared across priority areas. In addition, programs that are offering ongoing services to an individual are collecting a complete intake and a Social Determinants of Health (SDOH) survey for each participant. The SDOH survey is used to better understand the broad needs of a program participant and to confirm eligibility for ARPA funding. The survey is based on the validated Protocol for Responding to & Assessing Patients' Assets, Risks & Experiences (PRAPARE) tool used by Federally Qualified Health Centers.

CRP programs that collect individual-level data have assisted **3,143 people across the 9 priority areas**, providing **a total of 21,907 services** since program inception. Priority areas include: assistance to workers; childcare and childcare facilities; educational disparities; food assistance; financial assistance; housing and shelter; mental health; small business and non-profit; and culturally responsive disaster services. Additionally, programs that only track the number of services delivered have provided approximately **17,264 services to date**. The data clearly shows that food assistance was the most utilized service across all program areas, followed by financial assistance. This is not surprising given the impact of Covid-19 on employment and the rapid increase in cost of living. The housing and shelter priority area saw the third highest client levels. Households across the county struggle to make ends meet, so the availability of food and financial assistance was extremely valuable for the community. Other priority areas helped residents in job-training and securing new employment, provided scholarships to students and delivered much needed mental health care for residents (especially underserved youth).

The data below articulates the tremendous magnitude of investment made through the ARPA Community Resilience Program. Using the ARPA funds to support Community Based Organizations (CBOs) was an effective approach to get needed services to County

residents most disproportionately impacted by the COVID-19 pandemic. CBOs are trusted organizations where residents feel safe and have ongoing relationships with providers who can serve them in culturally appropriate ways.
