Resolution of the Board of Supervisors of the County Of Sonoma Amending the Department Allocation List of the County Administrator's Office, Effective November 16, 2021, and the Department Allocation Lists of County Counsel and Regional Parks, Effective December 14, 2021.

Whereas, on November 16, 2021, the Sonoma County Board of Supervisors approved Personnel Resolution 21-4061 amending the department allocation list for the County Administrator's Office, to reflect deleting 1.0 Department Analyst; and adding 1.0 Administrative Analyst I, effective November 16, 2021; and

Whereas, the Administrative Analyst series is an alternatively staffed, and the allocation list for the department needs to be corrected to reflect an Administrative Analyst III allocation should have been added on November 16, 2021, instead of an Administrative Analyst I allocation; and

**Whereas,** on July 1, 2021, the Civil Service Commission approved a classification study recommendation by Human Resources to reclassify 8.0 FTE Legal Assistant allocations in County Counsel to Paralegal, and retain the incumbents in accordance with Civil Service Rule 3.3B; and

**Whereas,** on September 16, 2021, the Civil Service Commission approved a classification study recommendation by Human Resources to reclassify a 1.0 FTE Administrative Aide in Regional Parks to a Project Specialist and retain the incumbent in accordance with Civil Service Rule 3.3B; and

**Now, Therefore, Be It Resolved** that the Department Allocation List of the County Administrator's Office is hereby revised as follows, effective November 16, 2021, and the Department Allocation Lists of County Counsel, and Regional Parks are hereby revised as follows, effective December 14, 2021:
