## Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,

## Proclaiming January 2022 As Positive Parenting Awareness Month

**Whereas,** raising children and youth to become healthy, confident, capable individuals is the most important job parents and caregivers have; and

Whereas, all people have inner strengths or resources, yet many parents and caregivers feel stressed, isolated, and overwhelmed, regardless of age, race, ethnicity, or income level – and this has worsened with the health, economic, and social-emotional impacts of the COVID-19 pandemic, wildfires and racial injustices; and

**Whereas,** the quality of parenting or caregiving – starting prenatally – is one of the most powerful predictors of children's future social, emotional, and physical health, and in Sonoma County, families come in many forms and children are raised by parents, grandparents, foster parents, family members, and other caregivers; and

**Whereas,** positive parenting is a protective factor that prevents and heals Adverse Childhood Experiences (ACEs), which impact lifelong health and well-being and occur in the context of Adverse Community Environments that lack equity; and

**Whereas,** in Sonoma County, families can receive support from various positive parenting programs, including the Triple P - Positive Parenting Program, an evidence-based program offered in English and Spanish by many organizations and individuals, thanks to a partnership between First 5 Sonoma County, Child Parent Institute, and the Sonoma County Human Services Department/Division of Family, Youth and Children's Services; and

Whereas, Triple P is an effective public health parenting intervention, benefiting over 20,000 diverse parents, providers, and children in Sonoma County since 2010 with a "tool kit" of proven strategies to strengthen relationships, promote children's development, and handle parenting challenges; and Triple P practitioners and other family support providers in Sonoma County quickly shifted to virtual services during the COVID-19 pandemic to maintain continuity and support children and families; and
