Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, Amending the Department Allocation Lists of the Human Services Department and the Department of Health Services, Effective March 1, 2022

Whereas, the departments are requesting these additions to increase their ability to serve the needs of an increasing population of older adults; and

Whereas, the increase in clients needing services is primarily the result of a change to the Welfare & Institutions Code redefining "elder" as those 60 years and older and making those between ages 60 and 64 now eligible for services.

Whereas, the Human Services Department is requesting authorization to add 9.0 FTE permanent allocations, 3.0 FTE time-limited allocations, convert 1.0 FTE time-limited allocation to permanent, and extend 2.0 FTE time-limited allocations effective March 1, 2022, as listed in the table below; and

Whereas, the Department of Health Services is requesting to add 1.0 FTE time-limited Senior Public Health Nurse allocation effective March 1, 2022.

Now, Therefore, Be It Resolved by the Board of Supervisors of the County of Sonoma that the Department Allocation Lists of the Human Services Department and the Department of Health Services be amended as follows:
