Resolution of the Board of Supervisors of the County of Sonoma, State of California, and the Board of Commissioners of the Sonoma County Community Development Commission Amending the Department Allocation Lists for the Department of Health Services, the Human Services Department, and the Community Development Commission to Extend 10.00 Full-Time Equivalent Time-Limited Positions, Effective May 3, 2022
