Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, Listing Projects To Be Funded By SB 1, THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 During

## Fiscal Year 2022-23

Whereas, Senate Bill 1 (SB1), the Road Repair and Accountability Act of 2017, was passed by the Legislature and signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

Whereas, SB1 includes accountability and transparency provisions that will ensure the residents of our County are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

Whereas, the County must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

Whereas, the County, will receive an estimated \$12,599,298 in RMRA funding in Fiscal Year 2022-23 from SB1; and

Whereas, this is the sixth year in which the County is receiving SB1 funding and will enable the County to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB1; and

**Whereas,** the County has undergone a robust public process to ensure public input into our community's transportation priorities/the project list; and

Whereas, the County used a Pavement Management System to develop the SB1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and

Whereas, the funding from SB1 will help the County maintain and rehabilitate 1368 miles of streets and roads, and 328 bridges, as well as adding active transportation infrastructure throughout the County this year and hundreds of similar projects into the future; and

Whereas, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the County's streets and roads are in an "at -risk" condition and this revenue will help to increase the overall quality of the County's road system and over the next decade will serve to bring County streets and roads into a "good" condition; and

Whereas, the SB1 project list and overall investment in local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.
