

NOTICE OF PUBLIC HEARING RELATING TO THE ADOPTION OF A SUPPLEMENTAL ORDINANCE AMENDING AND SUPPLEMENTING ORDINANCE NO. 1 AND AUTHORIZING THE ISSUANCE OF REVENUE BONDS OF THE SONOMA COUNTY WATER AGENCY

NOTICE IS HEREBY GIVEN that the Board of Directors ("Board") of the Sonoma County Water Agency ("Sonoma Water") will hold a public hearing on May 10, 2022, at 8:30 a.m., or as soon thereafter as is practicable, in the Chambers of the Board of Supervisors of the County of Sonoma, 575 Administration Drive, Room 102A, Santa Rosa, California. In accordance with AB 361, Governor Newsom's March 4, 2020 State of Emergency due to the COVID-19 pandemic, Sonoma County Public Health Officer's Recommendation for Teleconferenced Meetings, and the Sonoma County Board of Supervisors Resolution 21-0399, this meeting will be conducted via videoconference, with modified procedures by which members of the public may observe and offer public comment at the Board chambers. Members of the public are encouraged to watch, listen, and participate in the hearing through Zoom or by phone call, though in person public participation is available. Instructions for participating in the hearing will be published on the Board's agenda for its May 10, 2022, meeting.

The public hearing relates to adoption of an Eleventh Supplemental Ordinance that is supplemental to Ordinance No. 1, originally adopted by the Board on December 28, 1970, as amended and supplemented to date, providing for the issuance of revenue bonds. The Eleventh Supplemental Ordinance to be considered for adoption by the Board on May 10, 2022, is for the purpose of authorizing the issuance of revenue bonds in a principal amount not to exceed \$25,000,000 to fund any projects set forth in Sonoma Water's "Water Transmission Long Range Financial Plan," as it may be amended from time to time, and to refinance certain outstanding bonds previously issued by Sonoma Water.

NOTICE IS HEREBY FURTHER GIVEN that at said hearing the Board shall give all proponents and opponents of the Eleventh Supplemental Ordinance an opportunity to be heard on the question as to whether the Eleventh Supplemental Ordinance should be adopted, and all interested parties shall be given the opportunity to be heard.

NOTICE IS HEREBY FURTHER GIVEN that said hearing is being held in accordance with Section 30.17 of the Sonoma County Flood Control and Water Conservation District Act. For further particulars, reference is hereby made to the form of said Eleventh Supplemental Ordinance, a draft of which is available at the office of the Sonoma County Water Agency at 404 Aviation Boulevard, Santa Rosa, California 95403.
