FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This First Amendment ("Amendment"), dated as of May 19, 2022, is by and between the County of Sonoma, a political subdivision of the State of California ("County"), and DB Admin an Arizona LLC. hereinafter referred to as ("Consultant").

<u>RECITALS</u>

WHEREAS, County and Consultant entered into that certain Agreement, dated May 20, 2021 for database and system administration support with Integrated Justice System; and

WHEREAS, County and Consultant desire to amend the Agreement to extend services for an additional year through May 19, 2023, with additional funding not to exceed \$195,000 annually, and the option to extend an additional year through May 19, 2024, with additional funding for this extension.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

<u>A G R E E M E N T</u>

1. Paragraph 3, Term of Agreement shall be amended to read as follows:

The term of this Agreement shall be amended to extend the term for one additional year beyond the original end date of May 19, 2022 with additional funding not to exceed \$195,000 annually unless terminated earlier in accordance with the provisions of Article 4 from the original agreement. In addition, the County has the option to extend the term of this Agreement for one additional year, through May 19, 2024, with additional funding not to exceed \$195,000 during this time period.

2. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate or otherwise affect any provision of the Agreement or any right of County arising thereunder.

3. This Amendment shall be governed by and construed under the internal laws of the state of California, and any action to enforce the terms of this Amendment or for the breach thereof shall be brought and tried in the County of Sonoma.

COUNTY AND CONSULTANT HAVE CAREFULLY READ AND REVIEWED THIS AMENDMENT AND EACH TERM AND PROVISION CONTAINED HEREIN AND, BY EXECUTION OF THIS AMENDMENT, SHOW THEIR INFORMED AND VOLUNTARY CONSENT THERETO.
