Continuum of Care Background

- Continuum of Care (CoC) is a regional or local planning body that coordinates housing and services funding *for the region* for homeless families and individuals.
- Purpose of a CoC is to plan, organize and deliver housing and services to meet the specific needs of homeless persons as they move to stable housing and maximize self-sufficiency, preventing a return to homelessness.
- 17-member Board
- Meets Monthly (4th Wednesday of the month)
- Vice-Chair Coursey sits on the CoC Board (Supervisor Gorin is Alternate)
- County/CDC is the Collaborative Applicant and Lead Agency to the CoC.

2021 HUD Continuum of Care Awards

- The CDC submits annual consolidated funding applications to HUD in partnership with up to a dozen local non-profits.
- HUD Awards via a national competition in which up to twenty local homeless services projects are submitted together.
- \$4.1 million awarded to Sonoma County:
 - County receives some funding (\$1.5 million this year for CoCrelated programs)
 - Community-Based Organizations receive the remainder (another \$2.6 million)

2022 Homeless Program Contracts

- Mostly funded by HHAP, but...
- The approval of \$1.48 million in local funds by your Board in combination with funds approved by the CoC Board for contracts in March 2021 will result in level funding for up to 36 projects.
- Combined funds in FY 22-23 total \$4,562,269.11 and will be executed for a one-year period beginning July 1, 2022 and ending June 30, 2023.

Recommended Actions

- Authorize the Interim Executive Director or designee of the Community Development Commission (CDC) to accept \$1,533,126 in U.S. Department of Housing and Urban Development (HUD) Continuum of Care (CoC) awards on behalf of specific Sonoma County CoC Programs.
- Authorize the Interim Executive Director of the CDC or designee to execute a joint agreement with the State of California Interagency Council on Homelessness (ICH) to accept \$8,539,024.26 in County of Sonoma and Continuum of Care State Homeless Housing Assistance and Prevention (HHAP) Round 3 Funds upon receipt of a standard agreement





Recommended Actions (part 2)

Authorize the Interim Executive Director of the CDC or designee to execute FY 2022-2023 local homeless program contracts pending later Board of Supervisors FY 2022-23 budget approval of \$1,486,694.03 in local funds under the purview of the Board of Supervisors and including \$3,075,576.06 of State HHAP funds under the purview of the Continuum of Care Board (for a total of \$4,562,270.09 funds) in 2022-2023.
