Re: Springs Municipal Advisory Council Annual Report 2021-2022

The Springs Municipal Advisory Council (Springs MAC) would like to summarize our activities and accomplishments over the calendar year of 2021-2022 and cumulative updates for you and other members of the Board of Supervisors. Our summary is drawn from the complete record of activities extracted from our meeting minutes.

Monthly Meetings—the Springs MAC generally convenes the Second Wednesday of every month at 6:30pm. Prior to March 2020, meetings were in person at the Springs Community Hall. Currently meetings are virtually via Zoom with Spanish interpreting. We have adjusted our meeting schedule several times to accommodate Sonoma Valley Citizens Advisory Committee and the Sonoma City Council. We currently meet on the second Wednesday of the month at 6:30pm via zoom. The Springs MAC has expressed a desire to return to in person meetings and are in the process of determining a location. Council would like to offer a hybrid model so community members have the option to join in person or virtual.

Organizational year—The Springs MAC has been operational for three years. Since 2019 was the initial year following MAC formation, it was generally felt necessary by council members, staff and the chair to request key county department heads or designates to appear before the Council to introduce themselves and provide an overview of their departments' organization, mission and key objectives for Councilmembers. In addition, the MAC is interested in community voice and creating space for that voice to be heard in a public setting to uphold the democratic principles of our local government. The team tried unsuccessfully a number of times to find art opportunities in the Springs. The team investigate decorating PGE boxes, banners to hang from the light and mural options. All of these were met with barriers that made progress impossible for an all-volunteer group. Recently, we met with Sonoma County Transit to place bike racks at bus stops in the Springs. We will be able to add art to the racks that represent the Springs. This is pending approval from Sonoma County and Springs MAC. Sonoma County Transit has been very supportive and collaborative of this work.

Fire Ad Hoc has led to creation of Springs Fire Safe Council, which is completing the CWPP (Community Wildfire Protection Plan) and will have 1st community meeting on May 21st

The Emergency Preparedness/MYN Ad Hoc

The ad hoc was very productive during 2021 with Dana Bravo as a part time facilitator. Even hindered by Covid restrictions, much was accomplished. A grant for an additional 100 hours, thanks to Chair Iturri, the Catalyst Fund and Sonoma Ecology Center. This allowed for additional community outreach, work on name recognition for MYN and learning effective outreach from experienced community leaders. Dana has used Facebook as an information sharing hub, but a website would presumably be more easily accessed by a broad range of users.

- **JUNE-** With Covid restrictions loosening the Sonoma Valley Community Health Center (SVCHC) sponsored NeighborFest, providing COVID tests and vaccines, shared community resources, and reinvigorated community cohesion. MYN was represented at all these events—NeighborFest Tuesday June 15—extremely successful event, complete with nearby fire emergency! MYN helped sponsor June 16 NeighborFest Community Listening Circles at El Verano School. A preparation event at La Luz Thursday June 24 and a June 30th NeighborFest Glen Ellen at Abbott's Passage Winery. Additionally, zoom Meetings/Webinars: Parent University, *Charla Comunitaria, Lideres Campesinas, SVCHC - Latino Advisory Committee & Emergency Preparedness* pop-up. Continuing outreach accepting all invitations to present MYN and holding Block Leader meetings.
- **JULY** - Block leaders to hopefully calendar in-person meeting/s. NeighborFest July 8th at El Verano. Continued development of contact lists.
- **AUGUST** - Outreach slowed due to Delta variant, in-person opportunities reduced, still networking grass roots. Hosted a productive Block Leader zoom meeting in August. Some neighborhoods are making exact maps of participating homes. Neighborhoods doing very good networking. MYN worked at the MidPen apartments to organize the Celestina tenants.
- **SEPTEMBER** - Dana Bravo, MYN ad hoc member Reyes & Sonoma Sheriff's Community Service Officer Sylvia Floriano made an emergency preparedness presentation for Feters Apartments to find block leaders to train and implement MYN. Continued mapping, neighborhoods also organizing spontaneously(!), google maps introduced to all groups. NeighborFest (SV Health Center), Mexican Heritage Sept 19. In-person outreach was concluded for the Breathe Sonoma event at the season finale of the Tuesday Night Farmers Market.

- **OCTOBER**- Torrential rain saw Sonoma Creek going from empty to full within 24 hours. MYN is an all-emergency approach, so messaging on flooding and to update go-bags with cold weather/winter items. Some bilingual promotional materials were completed with MYN ad hoc member Reyes for the County of Sonoma Dept of Emergency Management on these topics as well. Continue to keep on track with FEMA messaging scheduling throughout the year for all types of natural disaster prep–tsunami, earthquake, flooding, fire, wind, power outages, etc. The long-awaited emergency supplies to be housed in the Springs arrived! The Conex Shed and supplies were delivered.
- **NOVEMBER** - An additional donation of emergency supplies was delivered by Catholic Charities in conjunction with the Red Cross to be kept in the Conex container. An inventory of donated items was completed and also includes a list of additional EP and clerical supplies needed/desired. [Connex Inventory](#)
- **DECEMBER** - All is calm with a reprieve from concern over wildfires for now. Reflecting on the year, much has been accomplished. In addition to outreach work and formation of MYN groups, partnerships with the Sonoma Ecology Center, Sonoma Valley Community Health Center, Julie Atwood's Halter Project, Sonoma Valley Fire District, Sonoma County, Catholic Charities, La Luz, and others were formed. Joined Sonoma County Community Organizations Active in Disasters (COAD). Working together towards strong community preparedness. Additionally, Dana spoke with Nancy Brown, SoCo Dept. of Emergency Management about hosting a LISTOS training in Spanish, to develop more leaders. This will be the more comprehensive UC Santa Barbara LISTOS training.
- **JANUARY** - The Emergency Preparedness-MYN effort is in a slow period. Refocusing priorities, working to recognize the possibility of all possible hazards.
- **FEBRUARY**- A to-do list for future work—not the least of which is finding funding (grants) for continuation of Dana Bravo as the bilingual representative working in the Springs for the very large effort to introduce emergency preparedness to the entire Springs area. Dana continues as a volunteer when possible, however this is not sustainable. Working with the developing Fire Safe Council is of interest. The SoCo COAD group recently held a meeting on needs assessment. Nancy Brown suggested a meet up with the CERT Bodega Bay representative to start a bilingual CERT group. Suggestions of working with FEMA, SoCo DEM on seasonally themed messaging and outreach. MYN ad hoc member Reyes did a bilingual promo video for DEM for the winter season.
- **MARCH** - Council informed of an April 30th preparedness event a test of the SoCoAlert messaging system for the Springs and Glen Ellen. Messaging is bilingual and results of calls connected will be tabulated and studied for improvement. Ad hoc member Reyes also met with Sam Willis of Emergency County Alerts. Chair Iturri reached out and received approval from Sonoma Ecology Center to continue to be the fiscal sponsor of MYN effort, we continue to search for funding sources to continue the work being done.

Future Agenda Items

The future agenda items under consideration are as diverse as the people of the Springs. We embrace and celebrate this diversity by honoring the people who live and work in the Springs. Part of leadership is understanding how the decisions made by folks in power affect the people who live with the consequences of these decisions. Our mission is to represent the people of the Springs and share their collective hopes and dreams with the Sonoma County Board of Supervisors (BOS).

Our community is asking for safer streets, health services and affordable housing. We will continue to advocate for these basic human rights and appreciate the BOS support is achieving these goals. The Springs is home to 30,000 residents who are worthy of a healthy and safe community.

The Springs MAC is concerned with Traffic and Pedestrian safety. We will continue to work with Supervisor Gorin to advocate for Caltrans and TPW improvements to our crosswalks, traffic signals, and roads. Mental health and equity continue to be our priorities and plan to invite Lt. Greg Piccinini of the SC Sheriff's department to explain the Sonoma Valley Mental Health Response Team as well as RISK and the Sonoma Valley Mental Health Collective. The council is also interested in updates on new and ongoing developments in the Springs and look forward to

updates from Mattson Projects (the Plaza, Lanning, Boyes Food Center), Hanna Projects, Sonoma Developmental Center and the Springs Specific Plan as well as housing preservation and protections in addition to Business and Restaurant permitting. Other ongoing topics include but are not limited to expanding the boundaries of the Springs MAC—similar to the North Sonoma Valley MAC declaration, E-waste and hauling event, community event planning for a late August event at Larson Park, and Springs Farmers Market.

In conclusion, we experienced several successes which included the shipment of the Conex and collection of emergency supplies at Altimira. We would like to thank American Red Cross, Catholic Charities and the Sonoma County Department of Emergency Services for their support and collaboration. They are very supportive of our work in the Valley. In addition, the outreach adhoc created a flyer, distributed among several organizations, attended a few in person events and shared on social media. Another success was the creation of a letter of support for the SDC project expressing the community's concerns and interests as well as the Caltrans letter requesting Traffic and Safety improvements. In addition, sponsorship of events such as the NeighborFest, *Día de Los Muertos* (November 2021) and *Día del Niño* (April 2022).

The Springs is a vibrant and diverse location within Sonoma County. The MAC and over all community continue to face barriers in the areas of mental health, safe streets, a plaza, art projects and additional emergency preparedness. We have an extraordinary group of committed individuals who are ready and willing to donate their time and talent to support their community. Yet, moving initiatives forward is difficult due to lack of resources and accessible processes. Road safety, lack of affordable housing and minimal health and human services are all issues the MAC continues to confront on behalf of our community.

We would like to thank Supervisor Gorin, Karina Garcia, Lin Marie DeVincent, Jordi from Language People, and KSVY for their ongoing support of our work.
