User will provide a certificate of insurance protecting the Golden Gate Area Council, and the National Council, Boy Scouts of America, from liability with a minimum coverage of \$2,000,000 combined single limit, which certificate shall name the Golden Gate Area Council and the National Council, Boy Scouts of America, as an additional insured.
2. User agrees to indemnify, save harmless, and defend the Golden Gate Area Council and the National Council, Boy Scouts of America, (including the performer, its agents, representatives, employees and members) from and against any and all claims, demands, actions, debts, liabilities, judgements, or any other costs arising out of, claimed on account of, or in any manner predicated upon loss of or damage to the property of and injuries to or death of any and all persons whatsoever, while in, upon or about the premises where-in the use is performing, or while going to or departing from the same, and to indemnify and save harmless the Golden Gate Area Council, Boy Scouts of America, from and on account of damages of any kind which the Golden Gate Area Council and the National Council, Boy Scouts of America (including the performer, its agents, representatives, employees and members) may suffer the result of any acts in any manner caused by or contributed to by the user, his agents, servants, or employees, in connection with the performance of this agreement.
3. Group or organization agrees that no drugs will be consumed or available on the premises.
4. Use is subject to approval of Council Executive and subject to authorization by Executive board.
5. Fees for use will be determined by the Director of Support Services.. Agreed fee: \$1200.00
6. Building facilities, program areas, and equipment use, including tents, etc., will be determined separately, subject to conditions set forth:  
  
**Prices listed are for 2 days: \$1200 .**
7. User agrees to reimburse the Golden Gate Area Council for any damage to the property for which they or members of their groups cause, such as broken windows or equipment.

8. This agreement, with attachments and deposit, must be returned to the Golden Gate Area Council as soon as possible to hold date you have requested.
9. **POOL (Royaneh/Los Mochos) or LAKE (Wente) USE:** It is required that you provide a Red Cross Certified Water Safety Instructor or BSA Safe Swim Defense Card; and SafetyAfloat Card (if using boats).
10. **REFUND POLICY:** Your request must be submitted in writing and received in our office no later than 48 hours prior to your event. A 20% of deposit due fee will be deducted from the refund. If any items have been purchased specifically for your group, this cost will not be refunded.
11. **TRASH MUST BE PACKED OUT.** We do not have trash pick up.
12. **NO PETS ARE PERMITTED IN CAMP!**
