LICENSE TO USE STATE READINESS CENTER OR FACILITY

It is **Mutually Agreed** as Follows:

1. That the LICENSEE shall comply with all applicable statutes, laws, ordinances and rules and regulations adopted by the Federal, State or any City, County or other body politic and which pertains to the said use of said premises or any provisions of the License.
2. That the LICENSEE shall not drive any nails, tacks, pins, or other objects into the floor, walls, ceilings, partitions, windows, woodwork, or other part of said premises, nor change in any manner or move any fixture on said premises, or make any alterations or changes in said premises without the written consent of the Board or Facility Commander.
3. That upon expiration of this license LICENSEE will surrender to the Board or Facility Commander the premises with its appurtenances and fixtures in good order, condition, and repair, reasonable use and wear thereof and Acts of God expected.
4. That this agreement shall not be assigned or sublet, in whole or in part, without the written consent of the Board or Facility Commander.
5. That the LICENSEE is responsible for providing temporary emergency exit lighting that meets all State, County and City codes unless the facility is so equipped.
6. That upon completion of the use of said premises, the LICENSEE shall promptly remove all decorations, displays, and equipment used on the premises by the LICENSEE.
7. That the LICENSEE shall comply with such reasonable rules and regulations as may be prescribed by the BOARD, THE ADJUTANT GENERAL and the STATE OF CALIFORNIA for the use and occupation of State Facilities.
8. That the Board or Facility Commander shall supply normal utilities for the use of said premises.
9. That LICENSEE shall indemnify and save harmless the Board or Facility Commander, the Adjutant General, the State and their officers, agents and employees against any and all loss, damage, injury or liability that may be suffered or incurred by the Board or Facility Commander, the Adjutant General, the State, or their officers, agents or employees cause by, arising out of, or in any way connected with the use of LICENSEE of the above premises or any part thereof or the exercise of the rights privileges herein granted.
10. That the Board or Facility Commander may cancel this license at any time upon repayment of any unearned license fee.
11. That this license shall not extend for a period of more than one year unless expressly so provided herein and provided further that the license is approved by the Department of General Services.

13. That the LICENSEE shall not suffer or permit any intoxicating beverage to be sold, offered for sale exposed for sale, stored, given away or otherwise disposed of or consumed in or upon any part of said premises.
