Status

The Evacuation Zone Access Ad Hoc Committee was established by the Board of Supervisors on February 1, 2022. The Ad Hoc Committee conducted four meetings during April, May and June in order to review recent County efforts, assess best practices, review potential options, assess media communications, and prepare for community engagement efforts including potential community meetings.

Staff, in partnership with the California Office of Emergency Services, surveyed other counties to determine if they were implementing similar programs and if so, how. Staff developed a report summarizing relevant authorities, requirements, guidance, stakeholders and best practices. The next

Ad Hoc activity will be a Community Workshop held during the July 19th Board of Supervisors meeting.

Fiscal Update

There are currently no fiscal activities related to the Ad Hoc Committee efforts. Existing County staff are serving as support to the committee and as subject matter experts.
