Concurrent Resolution Of The Board Of Supervisors Of The County of Sonoma, State Of California, And The Board Of Directors Of The Sonoma County Water Agency Amending the Department Allocation Lists for Human Services and Sonoma County Water Agency, Effective August 9, 2022.

Whereas, Human Resources conducted a classification study of Social Service Worker IV and Social Service Supervisor II positions allocated to the Adult and Aging Division of the Human Services Department; and

Whereas, Human Resources determined new classifications of Adult and Aging Social Worker and Adult and Aging Social Work Supervisor would more appropriately reflect the scope of duties, decision making authority, required level of specialized knowledge, and overall consequence of error which characterized the studied positions; and

Whereas, at their June 3, 2021, meeting, the Civil Service Commission approved the establishment of both new classifications, with the retention of the incumbents in accordance with Civil Service Rule 3.3C; and

Whereas, Human Resources conducted a classification study of a Water Agency Maintenance Worker II position and found the incumbent performed facility maintenance duties substantially similar to Building Mechanic I; and

Whereas, Human Resources, Sonoma County Water Agency, and Service Employees International Union participated in a meet and confer session regarding the recommendation of reclassification of the position and incumbent with satisfactory results; and

Whereas, Human Resources seeks approval to reclassify one position of Water Agency Maintenance Worker II to the existing County classification of Building Mechanic I, in accordance with the Sonoma County Water Agency Personnel Policies – Article V. and amend the Sonoma County Water Agency's Department Allocation List to reflect the deletion of 1.0 FTE Water Agency Maintenance Worker II and the addition of 1.0 FTE Building Mechanic II.

Now, Therefore, Be It Resolved that the Department Allocation Lists for Human Services and Sonoma County Water Agency are hereby revised as follows, effective August 9, 2022:
