SUBJECT: SELECTION OF SUPERIOR TANK SOLUTIONS, INC., FOR LONG-TERM

WATER TRANSMISSION STORAGE TANK MAINTENANCE SERVICES

Sonoma County Water Agency (Sonoma Water) intends to enter into a ten-year agreement for cleaning, inspections and maintenance of the interiors and exteriors of 18 water transmission system storage tanks.

Maintenance, including cleaning and inspection of Sonoma Water's 18 water system storage tanks has historically been completed by contractors that specialize in this work. This agreement will wrap the cleaning and inspections work into a comprehensive agreement that also includes maintenance of the interior and exterior tank coatings. Combining these services under a single agreement provides economy of scale to reduce costs and allows for better coordination of maintenance of these critical facilities.

On October 21, 2019, Sonoma Water issued a Request for Proposals (RFP) to the following 17 firms:

The three firms listed below submitted proposals.

- 1. Superior Tank Solutions, Inc.
- 2. Suez Advanced Solutions
- 3. Euro Style Management

The following criteria were used to evaluate each firm:

- 1) Professional qualifications and demonstrated ability to perform the work
- 2) Responsiveness to the work requirements
- 3) Exceptions to standard terms in the sample agreement
- 4) Thoroughness of proposal
- 5) Local Service Provider Preference

Superior Tank Solutions, Inc., (Superior Tank) was selected by unanimous consent of the RFP review committee based on their well-documented professional qualifications, thoroughness of its submittal package, and proven track record as confirmed with other California water districts that partner with Superior Tank on similar long-term maintenance agreements.

Proposals and evaluation forms have been sent to Central Records.

The hiring of Superior Tank for this agreement causes no conflict of interest and is not based on any financial incentive provided to Sonoma Water or its employees and representatives.
