EXERCISE OF OPTION TO EXTEND TERM OF CONTRACT

FIRST EXTENSION

On January 01, 2020, the County of Sonoma, a political subdivision of the State of California (hereinafter "County"), and Boys & Girls Club of Sonoma-Marin, a California non-profit corporation (hereinafter "Consultant"), entered into an Agreement to provide early intervention, prevention and case management services to juvenile offenders.

The Agreement term was effective for an initial period of two and one-half (2.5) years, commencing on Jan 01, 2020 ("the Effective Date") through June 30, 2022. The Agreement also included an option for the County to extend the term of the Agreement for three (3) additional one-year periods after the initial contract term.

The County is hereby exercising its option to extend this Agreement for the first extension, from July 01, 2022 through June 30, 2023.

Both parties hereby agree to extend the term of the Agreement pursuant to its original terms and conditions.
