**Concurrent Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, And the Board of Directors of the Sonoma County Water Agency Setting The Fiscal Year 2022-23 Countywide Tax Rate And Tax Rates For All Debt Service Funds Within Their Jurisdictions.**

**Whereas,** California Government Code Section 29100 requires that on or before October 3 of each year, the Board of Supervisors of a county shall adopt by resolution the rates of taxes on the secured roll, not to exceed the one-percent limitation specified in Article XIII A of the Constitution and Revenue and Taxation Code Sections 93 and 100, and

**Whereas,** the Board is required to set the Fiscal Year 2022-23 Tax Rates for all Debt Service Funds within the Special Districts governed by the Board and applicable School Districts, and

**Whereas,** the Tax Rates necessary to produce an amount sufficient to cover Debt Service requirements are listed in Exhibit "A",

**Now, Therefore, Be It Resolved** and ordered by the Board of Supervisors of the County of Sonoma and the Board of Directors of the Sonoma County Water Agency that the Tax Rates listed in Exhibit "A" be used as the Fiscal Year 2022-23 Countywide Tax Rate and Tax Rates for all Debt Service Funds within their jurisdictions, in accordance with Section 29100 of the Government Code, State of California
