



# **PROGRAM OF WORK STATUS REPORT**

### FOUNDATIONAL READINESS

- Secured EDA Grant for 27 Countywide Broadband Strategic Plans
  - Sonoma County Action Plan Complete Prior to Grant Submittal

### **TECHNICAL ASSISTANCE & CAPACITY BUILDING**

- 111 Applications Submitted (Total \$50.6M)
- 38 Applicants Participating with GSCA *Sonoma County Included*

# SUPPORT FOR SONOMA COUNTY

## Support provided to Sonoma County:

#### JOINT POWERS AGREEMENT

- Created a regional body that provides information to counties on grants, legislation and opportunities to increase broadband access
- o Increases economies of scale and identifies partners who are leaders in the broadband industry
- Advocates on behalf of counties to the CPUC and legislature
- Status: Sonoma County joined in October, 2021

#### • LOCAL AGENCY TECHNICAL ASSISTANCE (LATA) FUND

- Assisted the County of Sonoma in submitting an application to refine high-level design and develop construction-ready designs for priority areas
- GSCA is partnering with UTOPIA Fiber and Tilson Technology for implementation
- Status: Sonoma County Received LATA Grant and entered into an MOU with GSCA for grant implementation



# SUPPORT FOR SONOMA COUNTY

## How GSCA can support Sonoma County in the future:

#### • FINANCING


- Golden State Connect Authority is tracking the Federal Fund Account allocated by the state to fund \$2 billion of lastmile deployment
- Golden State Connect Authority plans to utilize the Loan Loss Reserve Fund to secure bonds to finance infrastructure construction
- Timeframe: Spring 2023

#### CONSTRUCTION

- Counties are able to enter into a Memorandum of Understanding with Golden State Connect Authority to establish expectations and roles
- Golden State Connect Authority will permit, build and operate infrastructure, inviting existing service providers to use the infrastructure to provide services to residents
- Timeframe: MOU is ready for local review and approval, infrastructure is dependent on financing
