

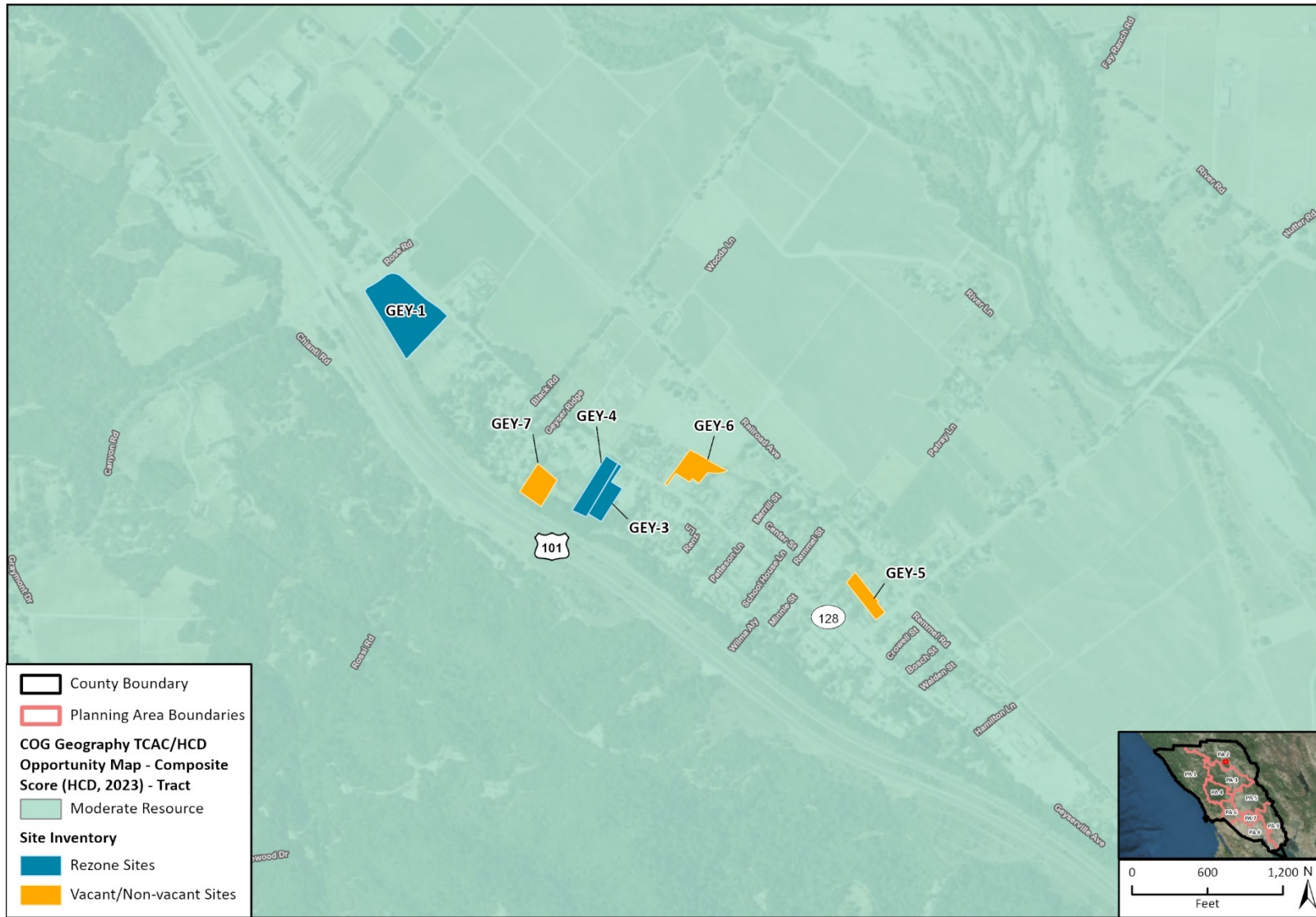
## HOUSING ELEMENT SITES

All sites listed in the table below are eligible for rezoning by the Board of Supervisors. Sites recommended for rezoning by the Planning Commission on the hearing of July 20 are depicted in the PC recommendation column.

Any future development on property rezoned by the project is controlled by the owner of the property. Amendments to land use and/or rezoning of the property do not require future development on the property. If existing legal uses on the property are not permitted under proposed zoning, existing uses would be allowed to continue on the property as legal non-conforming uses. 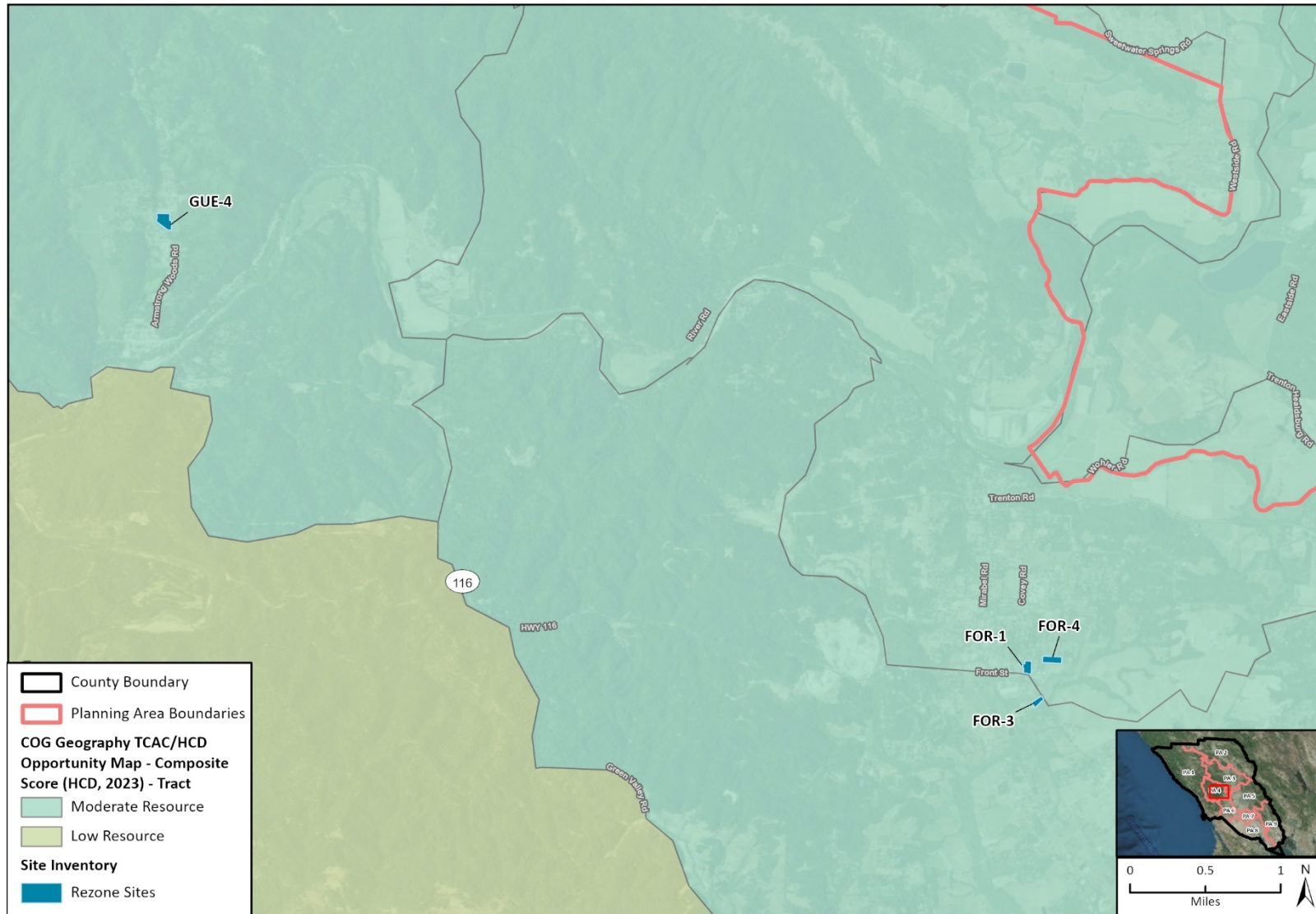

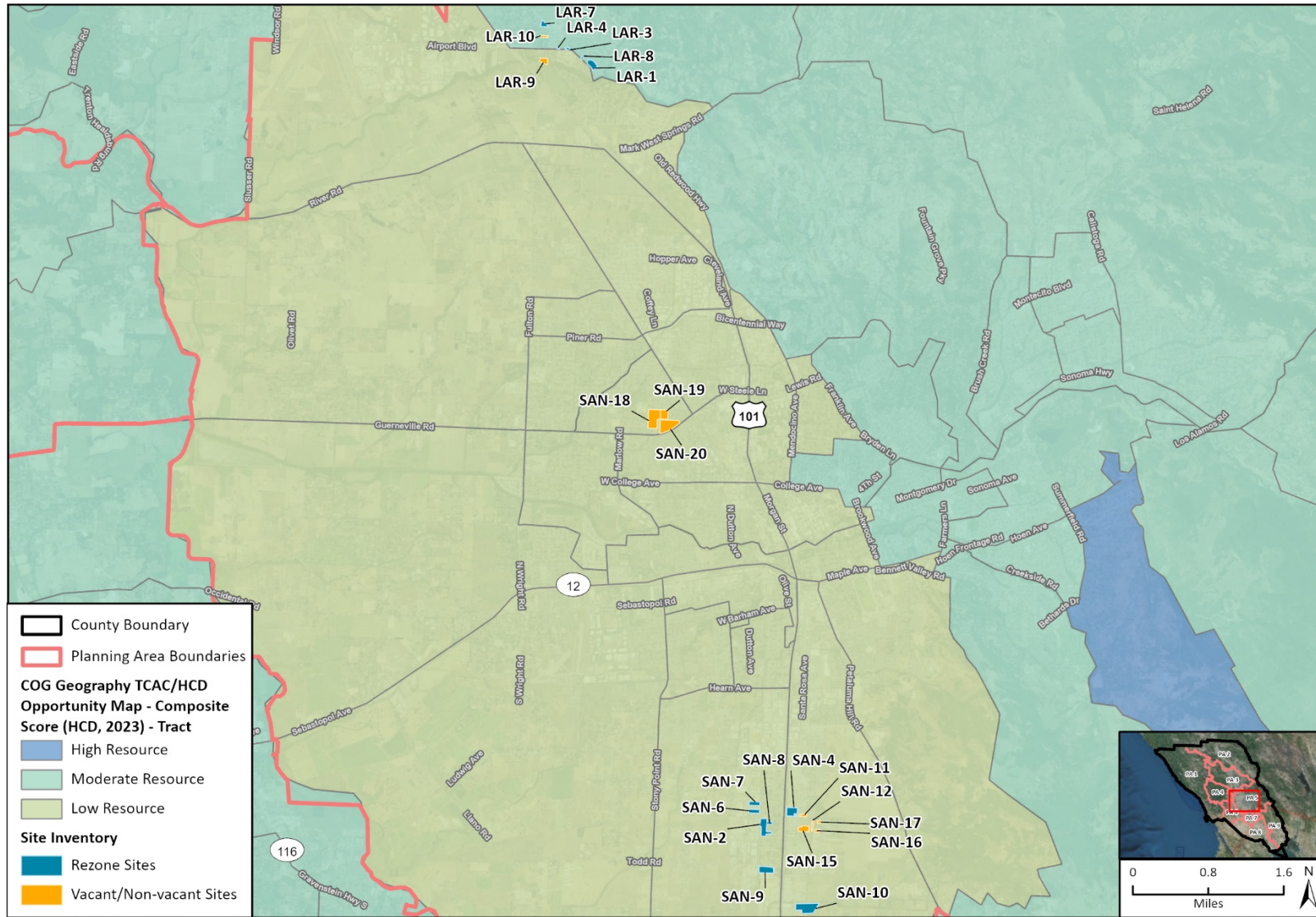

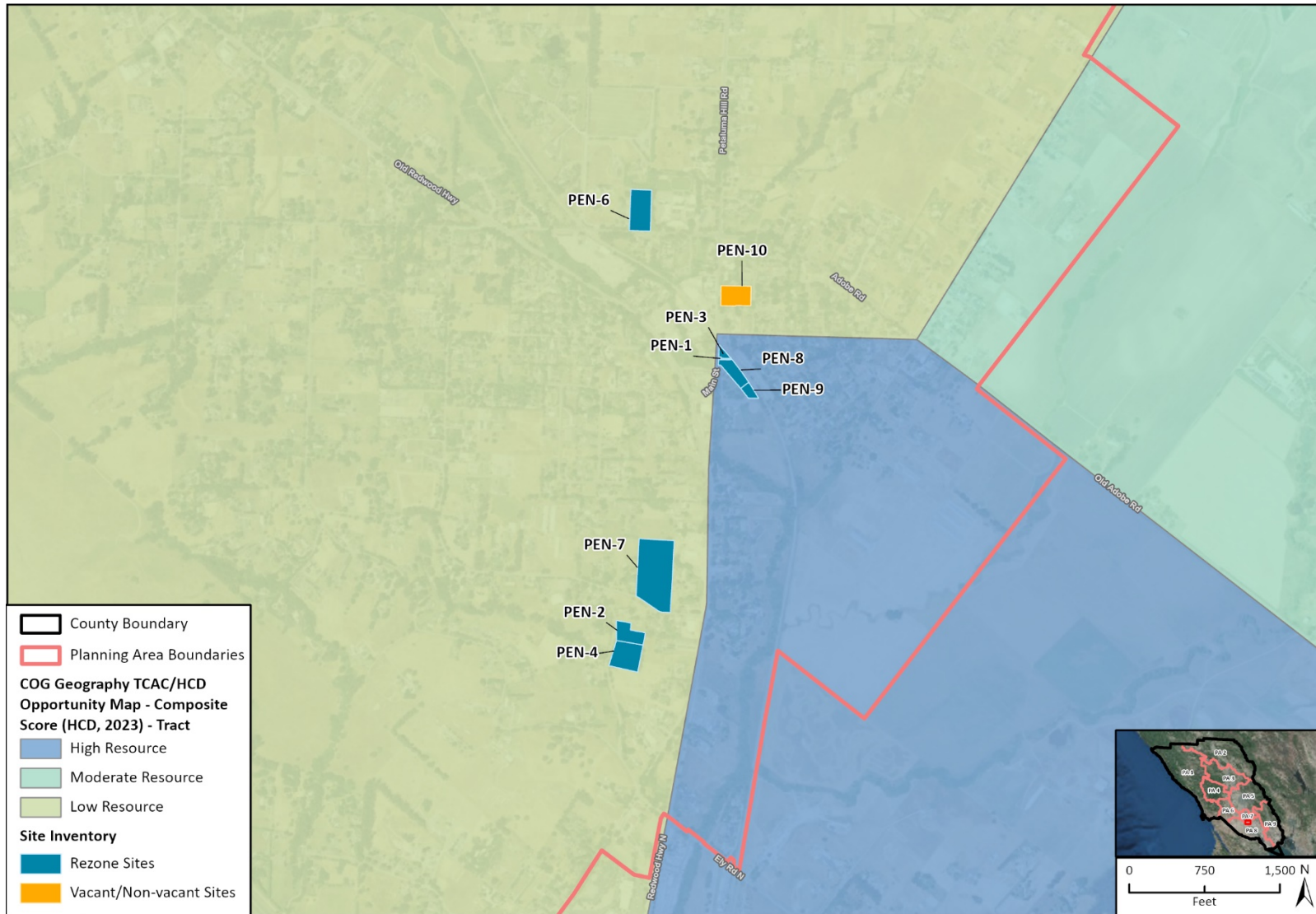
**Planning Area 6 – Sebastopol**

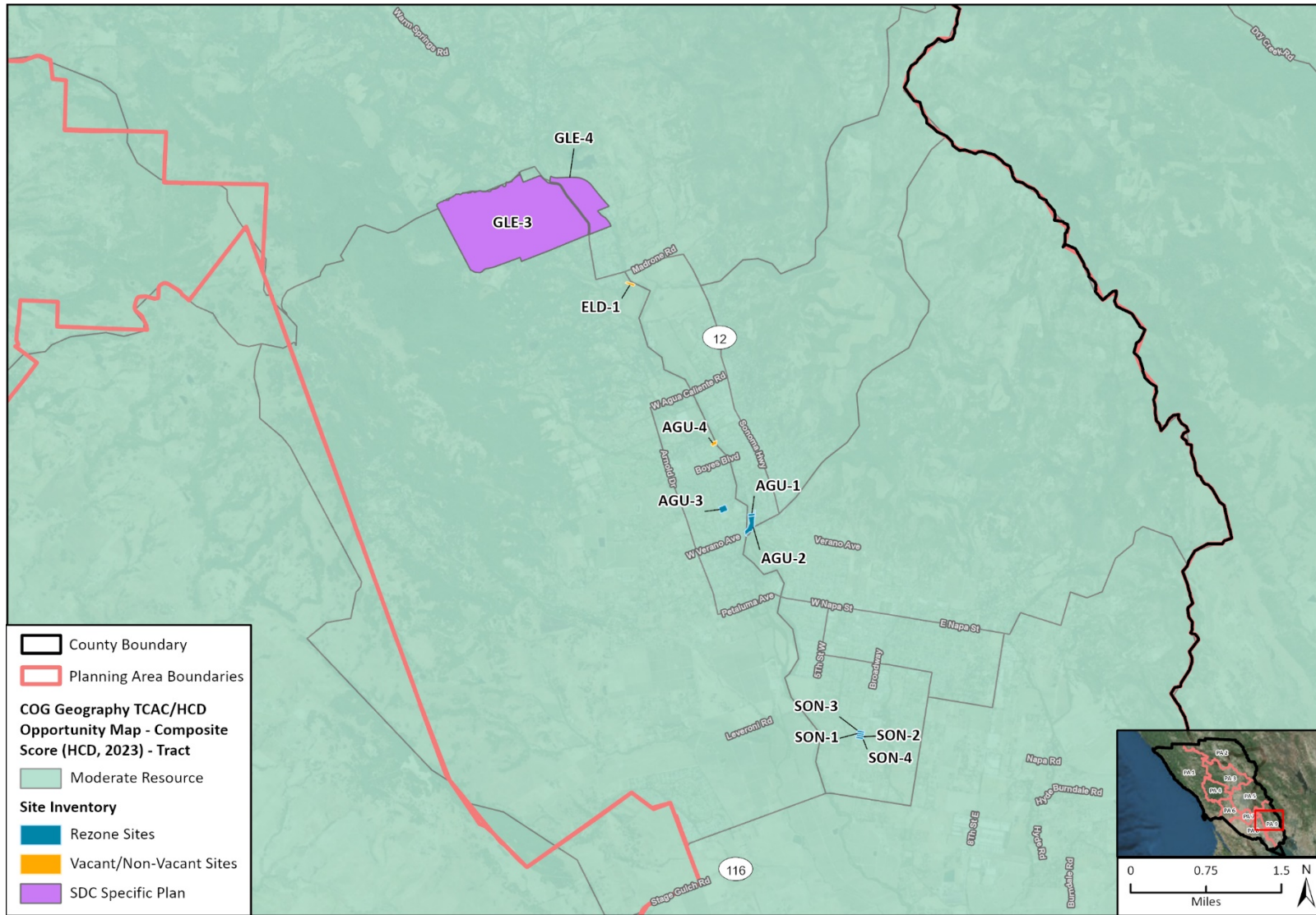

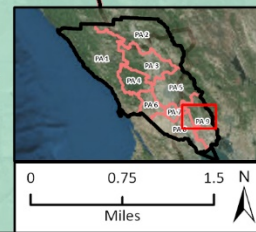
