**Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,  
Amending The Department Allocation Lists Of The Human Services Department and the Office  
of Equity, Effective October 29, 2024.**

**Whereas**, the Human Services Department is requesting approval to extend an existing 2.0 Full-Time Equivalent (FTE) Program Planning And Evaluation Analyst Time-Limited, an existing 2.0 FTE Administrative Aide Time-Limited, and an existing 1.0 FTE Accounting Technician Time-Limited through December 31, 2026, to better align positions with the operational needs of the department; and

**Whereas**, the Office of Equity is requesting the deletion of 2.0 Full Time Equivalent (FTE) Department Analysts – Time-Limited and adding 2.0 FTE Program Planning and Evaluation Analyst – Project through December 31, 2026, to meet the operational needs of the department, and as Project allocations due to specific funding; and

**Whereas**, positions previously added and extended to implement and monitor the American Rescue Plan Act Community Response Program are set to expire on June 30, 2026 and require a six month extension, and

**Whereas**, the extension of the positions will allow for technical support, successful closeout, federal reporting and compliance with the County’s Community Resilience Program participants,

**Whereas**, the Human Resources Department has reviewed the job duties of the positions and determined that the job classification changes are appropriate; and

**Now, Therefore, Be It Resolved** that the Department Allocation List of the Sonoma County Human Services Department is hereby revised as followed, effective October 29, 2024.
