## FIRST AMENDMENT TO BODY WORN CAMERA SERVICES AGREEMENTS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- Sales Agreement Q-195281-43494.049MH attached to as Exhibit A and incorporated herein by this reference shall replace Sales Agreement Q-11421-4 on the effective date of March 1, 2019.
- The Term of this Amendment shall be from March 1, 2019 through February 29, 2024, unless terminated earlier as specified in the Evidence.com Master Service Agreement.
- 3. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate or otherwise affect any provision of the Agreement or any right of County arising thereunder.

Execution of this quote will terminate contract #00003976 associated with Q-11421, and Q-1136161, as well as contract #00008090 associated with Q-73173 and Q-143213 with Axon and will start a new 60 month contract.

100% discounted hardware in Year 1, (2019), reflects the allotted TAP replacement from contract #00008090, (24 AB2 cameras, 4 6-Bay Docks, and 4 Wall Mounts).

The parties agree that Axon is granting a credit in the amount of \$\$169,946.75, which has been applied to Year 1 licenses on this quote in the form of a discount, to refund paid, but undelivered services in the form of licenses and TAP.
