2018 US Immigration and Customs Enforcement Data

The Sonoma County Sheriff's Office 2018 United States Immigration and Customs Enforcement (ICE) Programs participation is governed Government Code 7283.1 (d). Specifically:

- Government Code 7283.1 (d), part of Government Code Chapter 17.2 Standards for Participation in United States Immigration and Customs Enforcement Programs, requires that the Board of Supervisors hold a public forum to provide information to the public about ICE's access to individuals and to receive and consider public comment.
- The Code also specifies that the Sheriff may provide related data to the Board as part of this forum.

With regards to participation and cooperation with ICE the Sheriff's Office: protects public safety, helps undocumented victims obtain U-Visas, provides inmate release dates to the public, and provides inmate release dates per Senate Bill 54. The Sonoma County Sheriff's Office does not: enforce Federal immigration law, deport anyone, ask for immigration status, have authority over ICE, or conduct immigration sweeps.

In compliance with GC 7283.1(d), the Sheriff's Office has compiled the below ICE participation data for calendar year 2018.

Notification Requests Received from ICE for Impending Release Requests received from ICE for notification information. The majority of such requests are sent by fax to the Main Adult Detention Facility.	535

ICE Requests to Interview ICE requests for an inmate interview that are submitted to the Sheriff's Detention Facilities. These requests are usually received by phone, e-mail, or fax. All requests are documented by Sheriff's staff for tracking purposes.	3
Interviews Conducted The number of times an interview is conducted with the inmate's authorization.	1
Interviews Declined The number of times an interview is declined by the inmate.	2
ICE Requests for Information ICE requests for an inmate's information, such as release dates or charges. These requests are received by fax, e-mail or through phone inquiries to the Sheriff's Detention Facilities. All requests are documented by Sheriff's staff for tracking purposes.	151

Immigration Notification Criteria Forms Completed The Sheriff's internal process of reviewing ICE requests for notification. Upon receipt of any ICE notification request, Sheriff's staff completes an Immigration Notification Criteria Form. This measureable tracks the number of <i>forms</i> completed by the Sheriff's Pre-Trial Unit.	551
Immigration Notification Criteria Forms = Notification Immigration Notification Criteria Forms that result in an ICE notification of impending release.	108
Immigration Notification Criteria Forms = No Notification Immigration Notification Criteria Forms that result in no notification to ICE of impending release.	443
Inmates Reviewed for Notification Criteria Inmates who are reviewed. The number reviewed may differ from the number of Criteria Forms completed, as some inmates are reviewed multiple times.	414
Inmate Reviews Conducted Requests by an inmate or inmate's representative for the Sheriff's Pre-trial Unit to review the basis for determination of an ICE notification.	6
Inmate Review = Reversal of Results Reviews resulting in a new determination of an ICE notification	1
Inmate Review = Sustainment of Results Reviews resulting in no new determination of an ICE notification	5

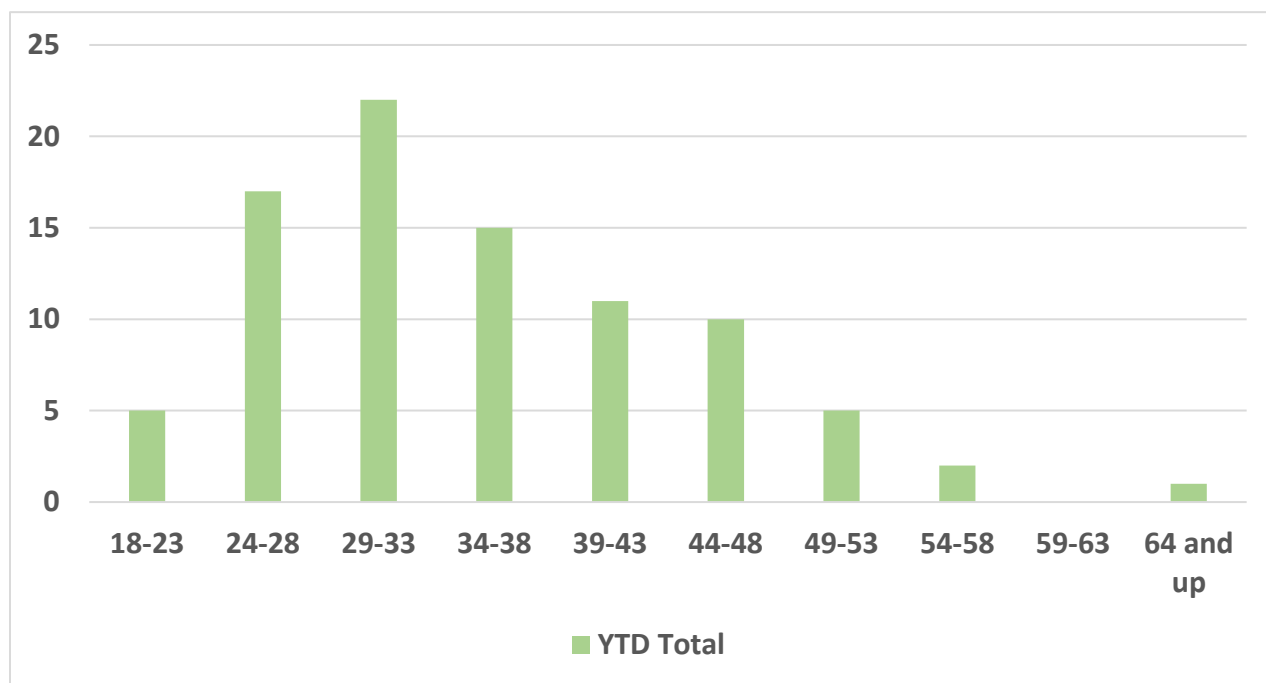

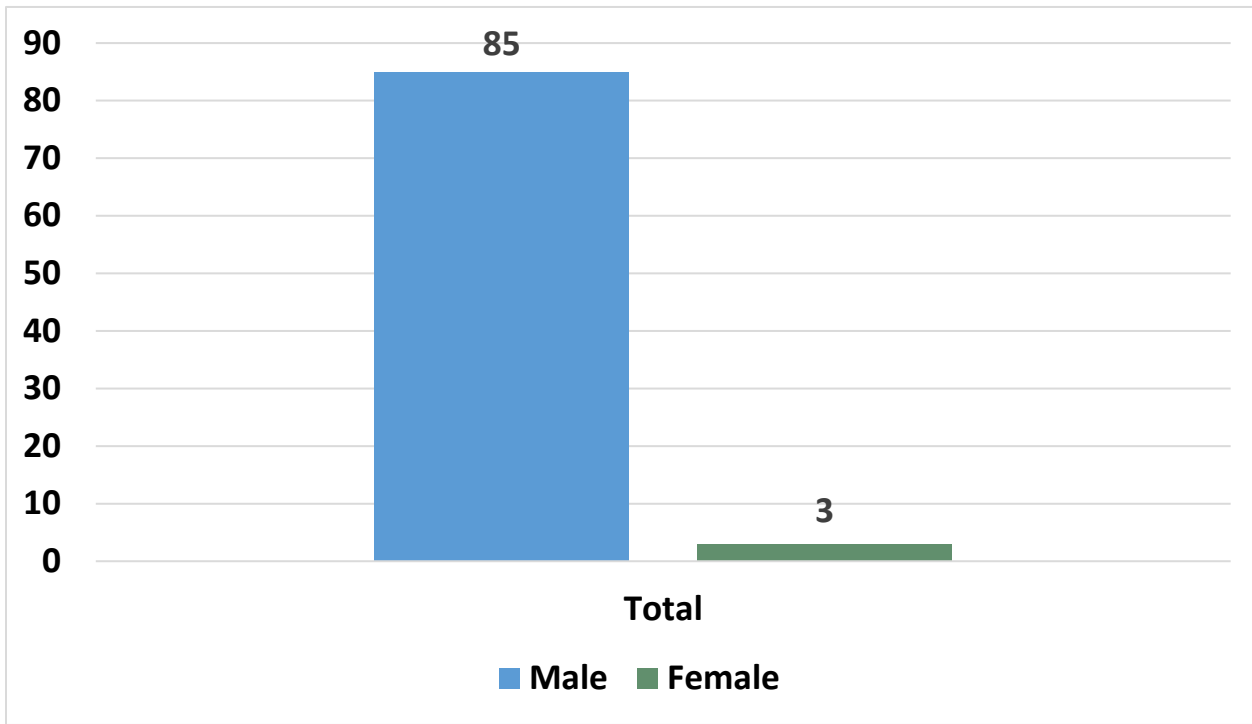
Booking Information Requests ICE contacted Sheriff's Law Enforcement Records staff to obtain information about a booking ("booking" refers to the process of receiving an arrestee into custody of the Sheriff's Detention Facility).	13

Warrant Information Requests ICE contacted Sheriff's Law Enforcement Records staff to obtain information about a warrant.	0
Warrant Information Returned	0
Crime Report Requests ICE contacted Sheriff's Law Enforcement Records staff to request a copy of a crime report.	22
Crime Reports Returned	7
Miscellaneous Information Requests ICE contacted Sheriff's Law Enforcement Records staff to request information other than booking, warrants, or crime reports. Examples: photo, fingerprints, extradition information, etc.	5
