

**AMENDMENT
TO AGREEMENT FOR LAW ENFORCEMENT SERVICES
BETWEEN THE COUNTY OF SONOMA AND THE CITY OF SONOMA**

This Amendment ("Amendment"), dated as of _____, 2019, is by and between the County of Sonoma, a political subdivision of the State of California ("County"), and the City of Sonoma, a municipal corporation located within the geographic borders of the County of Sonoma, hereinafter referred to as ("City").

RECITALS

WHEREAS, County and City entered into that certain Agreement, dated July 1, 2009, for Law Enforcement Services between County and City; and

WHEREAS, City desires to continue to contract with County for the performance of law enforcement functions within the City's municipal boundaries;

WHEREAS, County is capable of rendering such services under the terms and conditions set forth in its existing Agreement with City;

WHEREAS, County and City desire to amend Section 7 of the Agreement to extend the term by one year;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

AGREEMENT

1. Section 7, Term and Termination, sub-section (a), Term, is hereby deleted in its entirety and replaced with the following language:

“This agreement shall go into effect on July 1, 2019 at 12:01 a.m., and terminate at 11:59 p.m. on June 30, 2020, unless terminated earlier in accordance with Section 7, sub-section (b), Termination. Provided, however, this agreement shall not take effect unless City and County adopt a mutually agreeable FY 2019-20 Service Plan as described in Section 3, Annual Service Plan.

2. Except to the extent the Agreement is specifically amended or supplemented hereby, the Agreement, together with exhibits is, and shall continue to be, in full force and effect as originally executed, and nothing contained herein shall, or shall be construed to modify, invalidate or otherwise affect any provision of the Agreement or any right of County arising thereunder.

This Amendment shall be governed by and construed under the internal laws of the state of California, and any action to enforce the terms of this Amendment or for the breach thereof shall be brought and tried in the County of Sonoma.

COUNTY AND CITY HAVE CAREFULLY READ AND REVIEWED THIS AMENDMENT AND EACH TERM AND PROVISION CONTAINED HEREIN AND, BY EXECUTION OF THIS AMENDMENT, SHOW THEIR INFORMED AND VOLUNTARY CONSENT THERETO.
