Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, The Board Of Directors Of The Sonoma County Water Agency, The Board Of Commissioners Of The Community Development Commission, And The Board Of Directors Of The Sonoma County Agricultural Preservation And Open Space District Amending The Department Allocation Tables Of The Clerk-Recorder-Assessor's Office, Community Development Commission, County Counsel's Office, And Transportation And Public Works Department, Effective July 16, 2019.

Whereas, HR conducted a classification study of the Assessment Clerk and Assessment Clerk Trainee positions in the Clerk-Recorder-Assessor's Office and determined that reclassifying the positions to the appropriate levels of the Clerk-Recorder-Assessor Specialist series would afford the department greater operational efficiency while providing incumbents with greater opportunities for mobility and career growth; and

Whereas, on June 6, 2019, the Civil Service Commission approved Human Resources' recommendation to reclassify two Assessment Clerk positions to Clerk-Recorder Assessor Specialist II and three Assessment Clerk positions to Senior Clerk-Recorder Assessor Specialist, with the retention of the incumbents pursuant to Civil Service Rule 3.3 B.; and

Whereas, the Community Development Commission seeks approval for the deletion of 1.0 Community Development Assistant Manager and 0.5 Senior Office Support Supervisor allocations and the addition of 1.0 FTE Community Development Assistant Manager allocation to its department allocation table to address the increased demands on its Ending Homelessness programs; and

Whereas, the County Counsel's Office seeks approval for the deletion of 1.0 Deputy County Counsel IV allocation and the addition of 1.0 FTE Chief Deputy County Counsel allocation to its department allocation table to address its expanding body of work; and

Whereas, the Transportation and Public Works Department seeks approval for the deletion of 1.0 FTE Airport Operations Specialist and addition of 1.0 FTE Senior Airport Operations Specialist allocations to its department allocation table to support the Airport Operations Supervisor in the areas of scheduling, staff training, Airport/tenant
