On behalf of Attorney General William P. Barr, it is my pleasure to inform you that the Office of Justice Programs has approved your application for funding under the FY 2019 Transforming Family Justice Center Services: Creating New Pathways of Hope and Healing for Polyvictims in the amount of \$850,000 for Sonoma County District Attorney's Office. The money for this award comes from the Crime Victims Fund, which is administered by the Office for Victims of Crime (OVC). It is derived not from tax dollars, but from fines, penalty assessments, and bond forfeitures of convicted federal criminal offenders. The U.S. Attorneys in each District play a critical role in securing these funds to benefit federal, tribal, state, and local crime victims' programs. This Cooperative Agreement reflects the continuing commitment of the Department of Justice to improve the treatment of crime victims. The money for this award was authorized by 34 U.S.C. § 20103(c)(1)(A).

Congratulations on your recent award! The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) has been delegated the responsibility for ensuring that recipients of federal financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) are not engaged in discrimination prohibited by law. Several federal civil rights laws, such as Title VI of the Civil Rights Act of 1964 and Title IX of the Education Amendments of 1972, require recipients of federal financial assistance to give assurances that they will comply with those laws. In addition to those civil rights laws, many grant program statutes contain nondiscrimination provisions that require compliance with them as a condition of receiving federal financial assistance. 1. Requirements of the award; remedies for non-compliance or for materially false statements

The conditions of this award are material requirements of the award. 3. Compliance with DOJ Grants Financial Guide

9. Employment eligibility verification for hiring under the award

B. Employment eligibility confirmation with E-Verify

any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

E. Nothing in this condition, including in paragraph 4.B., shall be understood to relieve any recipient, any subrecipient at any tier, or any person or other entity, of any obligation otherwise imposed by law, including 8 U.S.C. 1324a(a)(1) and (2).

10. Requirement to report actual or imminent breach of personally identifiable information (PII)

13. Unreasonable restrictions on competition under the award; association with federal government

SCOPE. This condition applies with respect to any procurement of property or services that is funded (in whole or in part) by this award, whether by the recipient or by any subrecipient at any tier, and regardless of the dollar amount of the purchase or acquisition, the method of procurement, or the nature of any legal instrument used. The provisions of this condition must be among those included in any subaward (at any tier).

1. No discrimination, in procurement transactions, against associates of the federal government

The term "associate of the federal government" means any person or entity engaged or employed (in the past or at present) by or on behalf of the federal government -- as an employee, contractor or subcontractor (at any tier), grant recipient or -subrecipient (at any tier), agent, or otherwise -- in undertaking any work, project, or activity for or on behalf of (or in providing goods or services to or on behalf of) the federal government, and includes any applicant for such employment or engagement, and any person or entity committed by legal instrument to undertake any such work, project, or activity (or to provide such goods or services) in future.

B. Nothing in this condition shall be understood to authorize or require any recipient, any subrecipient at any tier, or any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

SUMMARY DESCRIPTION OF PROJECT (See instruction on reverse) The Office for Victims of Crime (OVC) is committed to enhancing the Nation's capacity to assist crime victims and provide leadership in changing policies and practices to promote justice and healing for all victims of crime. The project funded under this program will build on the lessons learned from the FY 2016 FJC Polyvictimization Demonstration Initiative to implement the validated assessment tool; increase partnerships with traditional and non-traditional FJC services to serve identified polyvictims more holistically; expand case management services to include a thorough understanding of the specific needs of the survivors; and build capacity to leverage existing and new resources for crime victims. The Family Justice Center Sonoma County will expand its trauma-informed, holistic service delivery to more effectively meet the needs of polyvictims. The FJCSC is a one-stop port of entry for victims of family and community violence to access services provided by multidisciplinary partner agencies. Through the proposed project, the District Attorney's Office and 25 partner agencies will provide holistic services that use a hope theory approach to mitigate complex trauma and		

reduce the risk of future victimization. Navigators will begin providing long-term case management, supporting polyvictim clients to identify their long-term goals and potential pathways to get there. The FJCSC and its network of partners will expand the practices, protocols and services developed during the demonstration initiative to promote the health and well-being of vulnerable polyvictim clients.
