Resolution of the Board of Directors of the Sonoma County Water Agency Amending the Department Allocation Table of the Sonoma County Water Agency, Effective November 19, 2019.

Whereas, a classification study conducted by Koff & Associates, a professional consulting firm, of all SEIU represented positions at the Sonoma County Water Agency determined the need for several new classifications; and

Whereas, the classification study recommended the reclassification of fifteen positions, including two Water Agency Senior Network Analyst positions and one Senior Programmer Analyst position to the new classification Water Agency SCADA Technology Analyst, the reclassification of one Department Information Systems Specialist II position, one Geographic Information Technician II position, and one Senior Geographic Information Technician position to the new classification of Water Agency Geographic Information Systems Analyst, and the reclassification of nine Engineering Technician I/II/III positions to the new classifications of Water Agency Engineering Technician I/II/III; with the retention of incumbents pursuant to Water Agency Personnel Policy, Article V – Reclassification; and

Whereas, Human Resources believes it has fulfilled its obligation to meet and confer in good faith on the reclassification recommendations for the represented positions;

Now, Therefore, Be It Resolved that the Allocation Table of the Sonoma County Water Agency is hereby revised as follows:
