

EXHIBIT "B" – NEW LEGAL DESCRIPTION FOR LANDS OF TRAVINSKY AND LAVERY – FOR PROPOSED RIGHT OF WAY VACATION OF PORTIONS OF THIRD, OAK, WASHINGTON AND SPRING STREETS PERTINENT TO APN 074-311-011, 074-300-003 and 074-300-004

All that certain and real property lying in the East ½ of Section 34, T.7 N., R.10 W., M.D.M., Unincorporated area, County of Sonoma, State of California, which is more particularly described as follows:

All those portions of the public rights of way known as Third Street, Oak Street, Washington Street and Spring Street as shown on the map entitled "*Plan of the Town of Occidental*" filed for record in Book 5 of Maps at Page 18, Official Records, Sonoma County Records, hereinafter referred to as *5 Maps 18, Sonoma County Records,* and being more particularly described as follows:

Parcel One, Third Street:

Per **5** Maps **18**, Sonoma County Records all that portion of the public right of way known as Third Street, bounded on the north by the northerly extension of the north line of Third Street to the westerly line of Oak Street and by the southerly line of Lots 196, 183, 170, 157, 144 and 131, on the east by the westerly line of Coleman Valley Road (formerly Grant Street), on the south by the centerline of said Third Street, and on the west by the westerly line of Oak Street, as shown on attached Exhibit "A", excerpted from Sheet 2 of 5 of the Record of Survey "Lands of Keith Travinsky and Linda Lavery..." recorded as 804 Maps 25-29. Sonoma County Records.

Parcel Two, Oak Street:

Per 5 Maps 18, Sonoma County Records the northerly fifty feet of the public right of way known as Oak Street as shown on aforementioned map and on attached Exhibit "A", excerpted from Sheet 2 of 5 of the Record of Survey "Lands of Keith Travinsky and Linda Lavery...", recorded as 804 Maps 25-29. Sonoma County Records.

Parcel Three, Washington Street:

Per **5** Maps **18**, Sonoma County Records the northerly fifty feet of the public right of way known as Washington Street as shown on aforementioned map and on attached Exhibit "A", excerpted from Sheet 2 of 5 of the Record of Survey "Lands of Keith Travinsky and Linda Lavery...", recorded as 804 Maps 25-29. Sonoma County Records.

Parcel Four, Spring Street:
