**Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California,  
Authorizing Adjustments to the Board Adopted Budget for Fiscal Year 2019-2020 for the  
County Administrator's Office and Non-Departmental in the Amount of \$160,000 for Climate  
Action Ad Hoc Committee staffing and legal support**

**Whereas**, the Sonoma County Board of Supervisors declared a Climate Emergency on September 17, 2019, acknowledging that human activities have warmed the Earth to a point that threatens climate stability, and climate change has already set in motion catastrophic changes to the Earth's systems, including fresh water scarcity and droughts, floods, extreme weather events and increased heat, wildfires, accelerating ice mass loss that will result in sea-level rise, and species extinction; and

**Whereas**, the County commits to educating its employees and residents about the climate crisis and the work needed to catalyze an equitable emergency climate mobilization effort at the local, regional, state, national and global levels.

**Whereas**, after the October 2017 fires, the Sonoma County Board of Supervisors formed the Office of Recovery and Resiliency to develop a framework for both fire recovery and greater community resiliency; and

**Whereas**, adding dedicated staff to the Office of Recovery and Resiliency will provide essential resources to lead county efforts and coordinate with community partners to advance the Board of Supervisors goals to address climate change; and

**Whereas**, The County Administrator's Office is requesting the addition of a 1.0 FTE Administrative Analyst position and County Counsel legal services to support climate action and resiliency efforts; and

**Whereas**, the Board of Supervisors adopted the County Administrator's Office and Non-Departmental Fiscal Year 2019-2020 budgets on June 14, 2019; and

**Whereas**, Sections 29088 through 29092 of the Government Code, State of California, allow for adjustments to the Fiscal Year 2019-2020 Adopted Budget.

**Now, Therefore, Be It Resolved** that the County Auditor-Controller-Treasurer-Tax Collector and the County Administrator are hereby authorized and directed to complete the budgetary and accounting transfers and adjustments to the Fiscal Year 2019-2020 budget as follows:
