Whereas, the Human Services Department is requesting authorization to add 1.0 full time equivalent Administrative Aide, 1.0 full time equivalent Employment and Training Counselor, 1.0 full time equivalent Human Services Aide II, and 1.0 full time equivalent Program Development Manager to the Employment and Training Division effective February 25, 2020; and
