AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SONOMA, STATE OF CALIFORNIA, AMENDING SONOMA COUNTY ORDINANCE NO. 2300 BY ESTABLISHING PARKING RESTRICTIONS ON RIVER ROAD, TRENTON ROAD, MARIANNA DRIVE AND ARGONNE WAY.

The Board of Supervisors of the County of Sonoma, State of California, ordains as follows:

Section I. Subsection 563 is hereby added to Section VII of Sonoma County Ordinance No. 2300 (said Section establishes No Parking zones) to read:

North side of River Road (#8802B) from Postmile 17.065 to 17.50 and the south side of River Road (#8802B) from Postmile 17.065 to 17.46.

Section I. Subsection 564 is hereby added to Section VII of Sonoma County Ordinance No. 2300 (said Section establishes No Parking zones) to read:

Both sides of Trenton Road (#89002) from Postmile 20.90 to 21.01.

Section I. Subsection 565 hereby added to Section VII of Sonoma County Ordinance No. 2300 (said Section establishes No Parking zones) to read:

West side of Marianna Drive (#89003) from Postmile 10.30 to 10.34 and the east side of Marianna Drive (#89003) from Postmile 10.304 to 10.34.

Section I. Subsection 566 hereby added to Section VII of Sonoma County Ordinance No. 2300 (said Section establishes No Parking zones) to read:

West side of Argonne Way (#89004) from Postmile 10.00 to 10.024.

Section II. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this Ordinance. The Board of Supervisors hereby declares that it would have passed this Ordinance and every section, subsection, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional or invalid.

Section III. This Ordinance shall be and the same is hereby declared to be in full force and effect from and after thirty (30) days after the date of its passage and shall be published once before the expiration of fifteen (15) days after said passage, with the names of the Supervisors voting for or against the same, in *The Press Democrat*, a newspaper of general circulation published in the County of Sonoma, State of California.
