Resolution Of The Board Of Supervisors Of The County Of Sonoma, State Of California, authorizing HSD to allocate \$46,833 into the current Fiscal Year 2019-20 budget for these agreements and the remaining \$95,755 into the Fiscal Year 2020-21 budget for a combined total of \$142,588.

Whereas, \$122,000 is funded by Victims of Crime Act (VOCA) grant funding received by the Human Services Department (HSD) for the period January 1, 2020 through December 31, 2020, by the Elder Abuse Program of the California Governor's Office of Emergency Services; and

Whereas, \$20,588 is funded by Realignment, for a combined total of \$142,588; and
Whereas, said VOCA funding comes with the provision of the promotion and building of
a multidisciplinary response to elder justice in Sonoma County; and

Whereas, Senior Advocacy Services and Legal Aid of Sonoma County will use VOCA grant funding provided by HSD to serve older and dependent adult victims of crime and to enhance elder justice resources in Sonoma County; and

**Whereas,** the Board of Supervisors authorizes the Director of Human Services to execute agreements for \$82,000 with Senior Advocacy Services and \$60,588 with Legal Aid of Sonoma County for a combined total of \$142,588; and

**Whereas,** the Board approves of HSD allocating \$46,833 into the current Fiscal Year 2019-20 budget for these agreements and the remaining \$95,755 into the Fiscal Year 2020-21 budget for a combined total of \$142,588; and

Whereas, the Board has adopted the Fiscal Year 2019-20 Budget for all Governmental
