MODIFICATION NUMBER THREE OF AGREEMENT FOR SERVICES BETWEEN COUNTY OF SONOMA AND CATHOLIC CHARITIES OF THE DIOCESE OF SANTA ROSA

On August 15, 2017, the County of Sonoma, a political subdivision of the State of California, (hereinafter "County") and Catholic Charities of the Diocese of Santa Rosa (hereinafter "Contractor") entered into a services agreement, modified by the parties effective June 11, 2018 as Modification No. 1, and modified by the parties effective July 29, 2019 as Modification No. 2 (hereinafter "Agreement").

Pursuant to Section 13.7 (Merger) of the Agreement, the parties hereby evidence their intent and desire to modify the Agreement as follows:

- 1. Exhibit B (Budget) is hereby deleted and replaced in its entirety with the attached Exhibit B (Budget).
- 2. Section 2.2 (Maximum Payment Obligation) is hereby revised to read as follows:
 - 2.2. Maximum Payment Obligation

In no event shall County be obligated to pay Contractor more than the total sum of \$2,025,000 under the terms and conditions of this Agreement.

- 3. Article 3 (Term of Agreement) is hereby revised to read as follows:
 - 3. Term of Agreement

The term of this Agreement shall be from July 1, 2017 to June 30, 2020, unless terminated earlier in accordance with the provisions of Article 4 (Termination).

- 4. Article 12 (Method and Place of Giving Notice, Submitting Bills, and Making Payments) is hereby revised to read as follows:
 - 12. Method and Place of Giving Notice, Submitting Bills, and Making Payments
