

## Current Sales Tax Breakdown by Jurisdiction

Effective April 1, 2019

The table below shows the current breakdown of sales tax by jurisdiction in Sonoma County. California law caps the total sales tax (including state and local portions) at 2% above State Sales tax. In September 2018, the Governor signed SB-152, which authorizes the County of Sonoma, its local jurisdictions, and SCTA to impose sales tax that would exceed the State limit of 2% by an additional 1%.
