SPONSORSHIP AGREEMENT (SONOMA WATER)

THIS SPONSORSHIP AGREEMENT is made as of the date of the last signature below by and between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a California constitutional corporation, on behalf of the Center for Water Energy Efficiency (CWEE) on its Davis campus (University) and SONOMA WATER (Sponsor).

The parties agree as follows:

- 1. **Sponsorship.** Sponsor agrees to be an industry partner sponsor of University's CWEE, and shall receive benefits for August 15, 2020 through August 14, 2021, as shown in Exhibit A, attached hereto and made part hereof.
- 2. **Payment.** Sponsor will send \$10,000.00 to the University for year one for a Sponsorship total of \$10,000.00.
- 3. **Endorsement disclaimer.** Nothing in this agreement shall be interpreted to indicate, imply, or otherwise suggest (i) that Sponsor supports, endorses, favors, or advances, any product or service offered, connected, or affiliated with University; or (ii) that Sponsor endorses, favors, supports, or opposes, any proposal, measure, program of action, campaign, or public appeal that is advocated, promoted, advanced, or opposed by any other person or entity with respect to the subject matter presented by University.
- 4. **Amendment.** This agreement may be amended at any time by amendment in writing and signed by the parties, and no other change in any term or condition shall be valid or binding unless made by amendment.
- 5. **Mutual Indemnification.** The parties agree to defend, indemnify and hold one another harmless from and against any and all liability, loss, expense, attorneys' fees, or claims for injury or damages arising from the performance of this agreement, but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of the indemnifying party, its officers, agents, students, or employees.
- 6. **Force Majeure.** Neither party shall be liable for delays due to causes beyond the party's control (including, but not restricted to, war, civil disturbances, earthquakes, fires, floods, epidemics, quarantine restrictions, communicable disease outbreak, freight embargoes, and unusually severe weather).
- 7. **Relationship of the Parties.** The parties to this agreement shall be and remain at all times independent contractors, neither being the employee, agent, representative, or sponsor of the other in their relationship under this agreement.
- 8. **Use of University's name.** Except as authorized in Exhibit A, Sponsor shall not use the name or mark of University in any form or manner in advertisements, reports, or other information released to the public without the prior written approval of University.
- 9. **Notice.** Notices shall be directed to the appropriate parties at the following addresses:
