Hello,

I represent the Department of Toxic Substances Control reviewing the Proposed Mitigated Negative Declaration for the PLP16-0050 project.

The Mitigated Negative Declaration text doesn't include a discussion of potential contamination present in the site soil itself, or in the water that is proposed to be used from the on-site well. The text discusses that the site has previously been used as a vineyard. There is no discussion regarding pesticides or herbicides that were used, best practices that were implemented etc. Past land uses could have resulted in hazardous materials releases within the project area that should be investigated prior to the proposed development project for public health protection. Past land uses could indicate the need for conducting a Phase 1 Environmental Site Assessment (ESA), Phase 2 ESA or other environmental sampling activities. This should be investigated to rule out potential risks to future customers and workers during project operation, as well as to construction workers during project construction.
