**Resolution of the Board of Supervisors of the County of Sonoma, State of California, Amending the Department Allocation Lists, Effective September 1, 2020, for the Department of Health Services, to Add 4.0 Full-Time Equivalent Time-Limited Positions for the Public Health Division through June 30, 2021 and the County Administrator's Office to add, 2.0 Full-Time Equivalent Time-Limited Positions in Central Communications through June 30, 2021 and 1.0 Full-Time Equivalent Project Position in the Office of Recovery and Resiliency**

**Whereas**, on July 27, 2020 the Director of Health Services presented to the Board an overview of a plan to allow for a sustainable COVID-19 emergency response through June 30, 2021 to continue the County's Response Efforts;

**Whereas**, the continuing COVID-19 response efforts require the replacement of the Health Services' Department Operations Center with a temporary Novel Coronavirus/COVID-19 Section within Public Health Division of the Department of Health Services and additional staff within the County Administrator's Office;

**Whereas**, the Health Services has identified a need to add 4.0 full-time equivalent time-limited positions to support the County's continuing COVID-19 response efforts through June 30, 2021; and

**Whereas**, the County Administrator's Office has identified a need to add 2.0 full-time equivalent time-limited positions through June 30, 2021 and 1.0 full-time equivalent project-limited position to support the County's continuing COVID-19 response efforts.

**Now, Therefore, Be It Resolved** that the Department Allocation Lists for the Department of Health Services and County Administrator's Office are hereby revised as follows:
