## Resolution of the Board of Supervisors of the County of Sonoma, State of California, Authorizing Budgetary Adjustments to the Fiscal Year 2020-2021 Adopted Budget to Reflect Additional Revenues and Expenditures Related to the Fiscal Year 2020-2021 Intergovernmental Transfer in the Amount of \$2,436,340 Within the Department of Health Services
