Describe the product or service:

Simpler Systems, Inc. develops, implements, and support a software platform that allows users to navigate independently using templates (called dataapps) accessing various data warehouses. Compared with static reports that need to be customized with each different query. Simpler Systems dataapp can produce hundreds, possibly thousands of reports, which anyone can run on their own, using one or combination of user interfaces. Simpler Systems is a proprietary software.

Simpler Systems was selected in 2005 initially as a way to produce a series of easy queries from the limited mainframe financial management system. The resulting datapp was known as EZFAMIS. Over the past nine years, end users became accustomed to the EZFAMIS functionality and the sheer ease and user friendly interface it provided. In 2014, Consultant developed EZeP for access to County's human resources data in the ePersonality application. In 2015, the Consultant extended the platform and templates to include new datasets to County's *new* financial management system (EFS by PeopleSoft) linking the old and new data. In 2016, ACTTC and ISD contracted with Simpler Systems for report writing and licenses of the three existing data warehouses (EZ FAMIS, EZ eP, and EZ Peoplesoft). ISD and ACTTC wish to renew this agreement to provide continued access to these data warehouses as well as additional requested reporting needs using this tool so that customers can better access financial and labor data.

- 1. Simpler Systems allows department specific reporting needs to be created from our mission critical ERP systems for both financials and labor. As these systems (FAMIS, PeopleSoft, ePersonality) will be retained for years, the reporting tool created and used will continue to be available.
- 2. Simpler Systems platform provides end users with a single, centralized view extracted from several disparate data warehouses in which the first such warehouse was accessed in 2005. Since that time, additional data warehouses have been added to create a multi-component solution used by all county departments for which County owns the licensing for all end users.
- 3. <u>User community embraced EZFAMIS because of its' user friendly interface. Other reporting mechanisms (SSRS/SQL) have not been able to meet the full needs of departments with the level of flexibility.</u>
