Resolution of the Board of Supervisors of the County of Sonoma, State of California, and the Board of Commissioners of the Sonoma County Community Development Commission, Authorizing Budget Adjustments to the Fiscal Year 2020-2021 Adopted Budget to Facilitate Use of \$4,987,187 in Emergency Solutions Grant Program Funding and Delegate Authority to the Interim CDC Director to Award Funds to Support Response to the Coronavirus Pandemic

Whereas, the Board of Commissioners for the Sonoma County Community Development Commission has adopted a Final Budget for the Community Development Commission for Fiscal Year 2020-21;

Whereas, Sections 29088 and 29125 of the Government Code allows for adjustments to the Final Budget during the 2020-2021 Fiscal Year; and

Whereas, Board of Commissioners and the Board of Supervisors have supported use of Emergency Solutions Grant Program funding to support the response to the COVID-19 pandemic.

Now, Therefore, Be It Resolved that the Board of Supervisors does hereby delegate authority to the Interim CDC Director to award \$4,987,187 in Emergency Solutions Grant Program funding to Support Response to the Coronavirus Pandemic; and

Be It Further Resolved that the County Auditor-Controller-Treasurer-Tax Collector is hereby authorized and directed to make budget adjustments to the Fiscal Year 2020-2021 Adopted Budget as cited in attached Exhibit A.
