Homeless Crisis

- California accounts for almost half (47%)
 of the U.S. homeless population.
- Sonoma County has the **4th** highest number of homeless.
- Affordable housing, permanent supportive housing, and transitional housing is critical to addressing the housing needs of the most vulnerable in the County.





Project Homekey as a Solution

 Project Homekey aims to protect homeless Californians from COVID-19.

• \$1.3 billion made available to counties to acquire and rehabilitate various housing options.

Hotel Azura

44 recently remodeled rooms located in the center of Santa Rosa can accommodate up to 66 individuals.

Sebastopol Inn

31 newly remodeled rooms can accommodate 31+ individuals.















Single bed unit with kitchen

Funding for Hotel Azura

- \$16,474,549 Overall project costs
- \$8,800,000 approved application for capital and acquisition funds
- \$1,056,000 operating funds from Project Homekey
- \$6,637,005 in matching funds
- \$1.6 million per year average over the first five years
- \$7,950,000 purchase price





Funding for Sebastopol Inn

- \$10,302,704 Total project cost
- \$6.375 million in acquisition
- \$744,000 in operating subsidies

The Sebastopol Inn is currently on the waitlist for Homekey funding.





COVID-Vulnerable Residents

- COVID-vulnerable: 65 years or older and/or with chronic or acute health conditions
- Homeless sheltered at Non-Congregate Sites (NCS) qualify for placement at the hotels.
 - Approximately 260 individuals have been served at the NCS
 - Approximately 177 individuals are currently being housed at:
 - Alliance Redwood in Occidental
 - Astro Motel in Santa Rosa
 - Trailers at the Fairgrounds in Santa Rosa





Community Engagement & Due Diligence

- Santa Rosa: Three rounds of meetings with residents near the Hotel Azura and one including CA-District 2 Senator Mike McGuire.
- **Sebastopol**: Meetings with the business community, City of Sebastopol leadership, stakeholders and residents.
- The CDC has conducted all required **due diligence** on both hotels, including a Phase 1 environmental report, lead and asbestos survey, title report and other investigations.





Services at these Permanent Supportive Housing Solutions

- The ACCESS Sonoma Initiative provides individualized, integrated services to homeless individuals based on their needs.
 - Primary healthcare
 - Behavioral health services and supports
 - Economic assistance
 - Food assistance
 - Transportation to appointments
 - Employment training
 - Other supportive services
- Food, medical, and security will also provided on-site.





Next Steps

- Continue community engagement sessions.
- Move individuals on interim basis.
- Begin a phased renovation process.







Recommended Actions

- A. Adopt a resolution granting the Interim Executive Director of the Sonoma County Community Development Commission, or designee, authority to execute purchase and sale agreements for the Hotel Azura at 635 Mendocino Avenue in Santa Rosa in the amount of \$7,950,000 and the Sebastopol Inn at 6751 Sebastopol Road in Sebastopol in the amount of \$10,302,704 in the event this project is removed from the waitlist and receives funding.
- B. Approve the funding plan of the Hotel Azura with sources of funding for the purchase of \$8,800,000 from California State's Homekey Program, \$2,000,000 in matching funding from one-time discretionary General Fund designated during the FY 2020-21 September Budget Hearings, matching funding of \$200,000 from Whole Person Care Housing Pilot Program, and \$1,056,000 in operating subsidies from the Homekey Program.
- C. Adopt a budget resolution amending the Community Development Commission FY 2020-21 Adopted Budget in the amount of \$9,856,000 for the receipt of Homekey State funding and expenses associated the purchase, capital improvements, and operations of the Hotel Azura. (4/5th Vote Required)





Recommended Actions

- D. Authorize resolution accepting Homekey funding from State of California in the amount of \$9,856,000.
- E. Authorize the Interim Executive Director of the Sonoma County Community Development Commission to execute and record All Documents Necessary To Accomplish The Sales.
- F. Authorize the Interim Executive Director of the Sonoma County Community Development Commission to file Notices of Exemption in compliance with the California Environmental Quality Act.
- G. Authorize the Interim Executive Director of the Sonoma County Community Development Commission to Execute the STD 213 Standard Agreement from the Department of Housing and Community Development and any amendments thereto.
