Allocations, and to Add 2.0 FTE Allocations, Effective November 17, 2020.

Whereas, the Human Services Department is requesting authorization to extend a 1.0 time-limited full-time equivalent Administrative Aide, with a current end date of November 30, 2020, through June 30, 2021, in the Administrative Services Division – Planning, Research, Evaluation and Engagement Unit; and

Whereas, the Human Services Department is requesting authorization to convert 1.5 time-limited full-time equivalent Employment and Training Counselor positions, with a current end date of November 30, 2020, to permanent ongoing positions in the Employment and Training Division, to focus on job development; and

Whereas, the Human Services Department is requesting authorization to delete 1.0 full time equivalent Office Assistant II and add 1.0 full time equivalent Senior Office Assistant in the Administrative Services Division, Special Investigations Unit, to support the processing of criminal, civil, and administrative investigations; and

Whereas, the Human Services Department is requesting authorization to delete 1.0 full time equivalent Account Clerk II and add 1.0 full time equivalent Accounting Technician in the Administrative Services Division, Finance Unit, to perform higher level duties related to grant programs;
