Concurrent Resolution of the Board of Supervisors of the County of Sonoma, State of California, the Board of Directors of the Sonoma County Water Agency, the Board of Commissioners of the Community Development Commission, and the Board of Directors of the Sonoma County Agricultural Preservation and Open Space District Amending the Memorandum of Understanding Between the County and Service Employees International Union, Local 1021, Salary Table Scales, Establishing the Classification and Salary for Parking and Facility Officer and Abolishing the Classification of Event Services Worker, Effective November 17, 2020.

Whereas, Human Resources (HR) conducted a classification study which resulted in a recommendation to establish the new classification of Parking and Facility Officer; and

Whereas, pursuant to the County's Employee Relations Policy, HR recommends the appropriate bargaining unit for the new classification is Bargaining Unit 0005 - Service Employees International Union (SEIU)/Service & Technical Support, Non-Supervisory; and

**Whereas,** HR has determined that the new classification is non-exempt, in accordance with the Fair Labor Standards Act; and

**Whereas,** based on an analysis of both market data and internal equity factors, HR recommends the salary for the Parking and Facility Officer be set hourly at the beginning range of 2287, as set forth in Attachment A; and

**Whereas,** the County and SEIU reached agreement on the salary recommendation and executed a Side Letter of Agreement as set forth in Attachment B; and

Whereas, the Civil Service Commission approved the adoption the new classification of Parking and Facility Officer and the abolishment of the Event Services Worker classification at their February 20, 2020 meeting.

Now, Therefore, Be It Resolved that the Memorandum of Understanding between the

County of Sonoma and SEIU – Local 1021, Salary Table Scales, be amended to establish the classification and the salary for Parking and Facility Officer and abolish the classification of Event Services Worker, effective November 17, 2020, as set forth in Attachment A.
