Concurrent Resolution of the Board of Supervisors of the County Of Sonoma, State of California, the Board of Directors of the Sonoma County Water Agency, the Board of Commissioners of the Community Development Commission, and the Board Of Directors of the Sonoma County Agricultural Preservation and Open Space District Amending the Department Allocation Lists of the Agricultural Preservation and Open Space District, Community Development Commission, General Services, Independent Office of Law Enforcement Review and Outreach, and Regional Parks. Effective November 17, 2020.

**Whereas,** on February 20, 2020, the Civil Service Commission approved a classification study recommendation by Human Resources (HR) to reclassify 2.5 FTE Community Services Officer IIs to Parking and Facility Officers and retain the incumbents in, in accordance with Civil Service Rule 3.3B, and

**Whereas,** during the FY 20/21 budget hearings, the Board allocated funding to the Independent Office of Law Enforcement Review and Outreach for 2.0 time-limited FTE attorney positions for two and three years, respectively; and

**Whereas,** on November 5, 2020, the Civil Service Commission approved HR's recommendation to establish the new classification of Law Enforcement Auditor and, and the Independent Office of Law Enforcement Review and Outreach seeks approval for the addition of two 1.0 FTE Law Enforcement Auditor allocations, and

**Whereas,** on June 18, 2020, the Civil Service Commission approved HR's recommendation to establish the new classification of Chief Park Ranger, and Regional Parks seeks approval for the deletion of 1.0 FTE Park Ranger III allocation and the addition of 1.0 FTE Chief Park Ranger allocation; and

**Whereas,** the Agricultural Preservation and Open Space District seeks approval for the addition of a time-limited 1.0 FTE APOSD Planner, through June 30, 2022 to work through a backlog of easement-related work; and
